A LITTLE BIT OF HERITAGE: Jim Haas “The Cost of a Recession”

In today’s economic climate, one can never be sure what industry or business will fall over next. The Fingal Valley cannot immune itself to the crisis, as most of our major employers are controlled by multinational companies with a strong reliance on world markets. History has shown many such companies appear to see dollars in front of their eyes, rather than the impact any closure of industries would bring to the communities in which they operate.

We saw a typical example of this back in 1981 when Forestwood Holdings, a multination company based in Sydney, purchased the Aberfoyle Tin and Wolfram mine at Rossarden for a reported one million dollars. At the time, it was wonderful news for the 500 or so residents of Rossarden and, indeed, for those working at the mine who lived down in the Fingal Valley.

Forestwood created an immediate sense of optimism by spending large amounts of money on upgrading plant and equipment. Employees’ houses were improved and plans for a sewerage system, to replace the existing “night cart”, was submitted to the Fingal Council.

The sewerage system was never started, however. On the 25th February 1982, one year after the Forestwood takeover, it was announced in the Examiner newspaper that the Rossarden tin mine had dismissed 130 employees. This amounted to three-quarters of its workforce, bringing the underground operation, which had been operating for 50 years, to a close. Forty staff were maintained to rework the tailings, but this, too, was short lived.

In just 12 months the town of Rossarden had gone from riches to rags. Almost instantly families had to move away to find work and by October 1982 the town’s population had dropped to around 90.

On the 25 October 1982, the remaining residents were given a stark reminder of the finality to what was once their livelihood, when plant and mining equipment went up for auction. Then, on Saturday the 30th, over 2,000 people gathered at the tennis court where 40 homes and 14 residential blocks were sold.

House prices varied from \$100 to \$700 and sitting tenants were offered their homes for \$1, but few stayed, with families choosing to move to where they could find work. Many of the houses purchased were dismantled or moved to other areas.

One can only wonder why a mine, which made another headline in the Examiner back in 1968 by announcing the discovery of a new lode, with reserves of 340,000 tons of ore and an expected life span of over 30 years, could end so quickly, and it would appear heartlessly, just 14 years later.

Rossarden is today, like Mathinna and Mangana, only a fraction of its former glory, but the town has survived, mainly due to a strong vibrant community spirit. It is a unique town, set in the eastern shadows of Ben Lomond, where deer and other forms of wildlife can roam free and without fear amongst the remaining dwellings. In season, the array of colours displayed in the lupins that have taken over much of the vacant land, is a sight to behold. In summer the temperature can rise to equal any in Tasmania and in winter, even though your milk may freeze before it reaches your cup, the raw, natural, beauty of the snow covered mountain towering above the town will stay in your memory for ever.

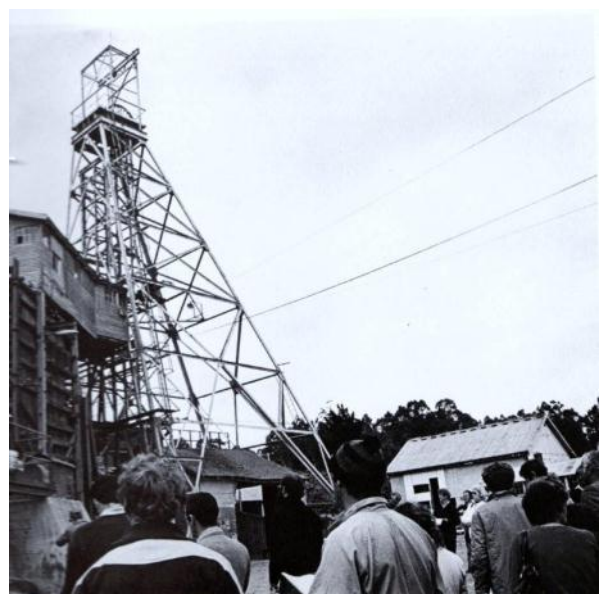
The 1980-82 recession, which caused a dramatic fall in the price of tin, was obviously the major factor in the investors’ decision to close the Aberfoyle mine. The fact remains however, that decision made tin mining at Rossarden just a part of our history and the chance of a revival in today’s climate is most unlikely.

Let us hope then, that in the 2009 recession, the price of coal and timber remains steady, because the Fingal Valley could well afford another Rossarden debacle.

Pesticides have become a major health problem for the community. Please find below a copy of a letter I have addressed to the Mayor and Councillors of the Break O'Day Council on this issue. I believe that readers of the Voice need to be aware of this situation.

The Mayor & Councillors, Break O'Day Council

Public Health and Pesticides

This letter updates you on the outcome of a public meeting on community health and pesticides. This meeting was held at the Tailrace Convention Centre, Launceston on Thursday 26th March 2009 and was attended by approximately 500 people.

Professor Tyrone Hayes, the internationally recognised expert on the health effects of pesticides, informed the meeting of the latest research that links pesticides to reproductive hormone imbalance and to several types of malignancy such as breast and prostate cancer. Professor Hayes gave an account of how hormonal imbalances created by pesticides also lead to less testosterone in men, with lower sperm counts and a general effect of demasculinisation.

This is a horror story for Tasmanians who have the highest rates of cancer in Australia (excluding skin cancer). In addition, rates of prostate cancer in Tasmania have increased rapidly over the past 20 years.

Increasing rates of acute illness in this state have coincided with the increased usage of pesticides sprayed on plantations and farmland in Tasmania.

European countries have banned pesticide spraying until it can be proven that pesticides do not adversely affect public health. This is the precautionary principle at work. No chemical company has yet been able to prove that these chemicals are safe.

The Break O'Day Council has a moral as well as a legal responsibility for the public health of the municipality: (S, 20, 1, a, of the Local Government Act) and therefore should, as a first step, move to ban the aerial spraying of pesticides in the municipality.

Letter to the Editor

Dear Editor,

It would appear that some confusion has occurred from my letter to your paper of 12th March. Although my remarks dealt almost exclusively with local government, in your last edition, Jeanette Peryman in answering, dealt almost exclusively with State and Federal matters, none of which was mentioned by me. She also talked about aborigines and votes for women. I have no idea why, as it was totally irrelevant and had nothing to do with the subject being discussed. However, it was gratifying to see that the Break O'Day Council prudently decided to say **nothing**.

Let me clarify things and share some history with you. In the time of King John and Magna Carta 1215, things were very different from what they are today. The King was the Ultimate Authority but local affairs were dealt with by the "elder men" (Aldermen) of the separate villages. In those days it stands to reason that communications of any sort were almost non-existent, so a kind of local government grew out of the need to make decisions about the local area in consultation with the locals, and **Magna Carta** gave the people their legal rights in written form.

Two very important pieces of law were set down in the "Great Charter" being **Habeas Corpus**, which translates to "I own my body" and **Fee Simple** which means "I own my land" It is true, as stated by Jeanette Peryman, that police and other essential services can enter your property in cases of criminal lawbreaking or emergency matters. This is a relaxation of your property rights agreed upon by landholders for their mutual safety and protection. Nobody would want to keep the fire brigade out whilst their house was on fire.

As land was given by the Crown, **totally** without any conditions imposed, the ownership was as the title reads **Fee Simple Absolute**. As this land passed down through the ages or was sold, there were no conditions added, and how could there be? These aforementioned statutes were the **People's Law**, and because they were taken from teachings of the Bible, were considered to be **sacred** and called **Canon Law**.

In 1688, when William and Mary of Orange, who were commoners, were offered the throne, it was subject to them agreeing to uphold the rights of the people in the Coronation Oath which every monarch since then has had to swear and sign, right up to the present day and beyond. **As long as we have a King or Queen as our Head of State these Rights will continue**. Something worth remembering!

At the time of European Settlement, **Fee simple** and **Habeas Corpus**, together with several other Statutes of Westminster were the laws of Australia and still are. So how can laws that give you **total rights** to your land, that have been in force for **800 years** be overturned by State or Federal Governments and especially with illegal so called laws conjured up by our local administration? The truth is they can't unless you let it happen! This matter was proven in the following trial. In 1991 it is recorded in the case of Plenty and Dillon, that Plenty, (a policeman) went onto the land owned by Dillon to issue him with a summons and refused to leave when told to do so.

Dillon charged Plenty with **trespass** and the case was **rejected** by a local court. Dillon then took the matter to the High Court and the charge was **upheld** using old English case law. The police had to pay compensation of \$162,000 and costs believed to have been around \$600,000, thus proving conclusively, once and for all, that our ancient and inherited laws override all other laws.

If our Council has any further argument with this, then all that they have to do is come onto my land uninvited and refuse to leave and see what the result will be.

It could be interesting!!!

Waste collection charges

As a Councillor I receive from time to time a sufficient number of enquiries about Council waste charges for **domestic waste**, to suggest that there is some confusion about why there is a charge for depositing household waste at the tip when all rateable properties already pay a waste charge. I hope that the following explanation clarifies the way the system works. If it just confuses you more, please ring me any evening and we can talk it through.

A **Waste Management Service Charge** of \$110 is currently raised on all rateable properties. This is a standard charge to cover the cost of the management and basic operation of the waste system and the provision and maintenance of waste infrastructure throughout the municipality. This charge is paid equally by all property owners irrespective of how much or what type of waste is generated by the property. The waste management service charge does not cover the cost of collection and treatment of the domestic waste actually generated by a household – this is subject to a separate user pays charge. The uniform service charge is a flagfall charge, not a mileage charge.

The waste actually generated by residents and businesses is subject to user pay charges for its collection and treatment- there are different charges for different types of waste- domestic and green waste, builders waste and rubble, tyres, commercial business waste, tree lopping material, clean fill material, etc..

Domestic waste generated by the normal day to day running of a household is either collected from the front gate of a household through the wheelie bin service, or it is collected from the local waste transfer station (WTS) (the “tip”) where it has been deposited by the householder. In either case a user pay charge is made for the collection and treatment of that waste. The charge is either a **mobile garbage bin collection charge** of \$65 per year for 33 collections from the front gate (about \$2 per collection), or \$2 per **car boot or station wagon** load deposited at the WTS. These charges are made to recover the contractor costs of collecting the domestic waste you generate, either from your front gate or from the skips at the WTS, and its subsequent transport, compaction and cartage to the land fill site.

If you are in a bin collection zone, your property automatically has its domestic waste collected 33 times a year and your rate notice includes the collection charge of \$65, in addition to the universal standard waste management charge of \$110. A bin has a volume of 240litres. If your household generates more than 240litres of waste per fortnight, either regularly or from time to time, and you take the extra waste to the WTS you will pay an extra \$2 per load to cover the cost of collecting and treating the extra waste. If you do not have a wheelie bin, and so deposit your waste 33 times a year at the WTS, you will pay the same over the year as for wheelie bin collection; you will pay less if you don't go to the WTS as often because you don't generate as much waste, or more if you are a high waste generating household. These charges cover the cost of collecting and treating the domestic waste that comes out of the day to day running of your household, whether it is collected at your front gate or from the WTS.

It is not justifiable to claim that going to the tip takes up your time and costs you money in petrol etc. Where you live is a lifestyle choice. Try getting a discount on your newspaper, bread and milk, library fine or whatever because you live on top of the hill or back of whoop whoop.

The system provides for an equal contribution by all to meet the fixed costs of organising the system and providing the facilities, and a comparable charge for all for collecting the domestic waste you actually create, whether you deposit it at the front gate in a bin to be collected or deposit it in a skip at the WTS to be collected.

The total cost of the overall waste management system for a household in a bin collection area is \$175 per year (\$110+\$65), or \$3.36 per week- the cost of a bag of marshmallows. I believe that most residents would accept that as a minimal cost for the public health benefits alone.

I have not addressed here the issue of recycling, or some other issues such as tip hours, the option of different sized bins, etc., which could be the subject of further discussion. This outline has been intended to focus on the single issue of why do I have to pay to go to the tip when I already pay a waste service charge in my rates? I hope this explains the reasons- if not, please contact me so that I can understand your point of view. (6372 2647)

St Marys Police report

In my absence, the last issue of the Police Report was submitted a fortnight earlier than I intended so I do apologise for reinforcing some points I wish to make for the Easter message.

It has been obvious with the end of daylight savings and the recent cold weather that winter is just around the corner. Legislation requires drivers to turn on their lights (headlights not just park lights) approaching dusk and also in inclement weather. So often I see drivers (more often than not in dark coloured vehicles) failing to carry out this simple task which apart from obeying the law, is a safe/considerate action to take. I can advise readers this aspect of road safety/policing will be enforced by all police personnel and in particular officers from the St Helens Division. Save yourself a traffic infringement of 2 demerit points and \$110 fine through a simple flick of a switch.

During the Easter holiday period expect to see an increased police presence and numerous traffic operations. In particular police will continue to target the main causal factors in fatal and serious injury accidents, namely inattentive driving, drink driving, speeding and failing to wear seat belts. Inattentive driving includes such things as using mobile phones, failing to indicate and disobeying road signs and road markings.

Easter in the Break O'Day Municipality not only brings an increase of traffic to our roads but also the increase usage of our waters. If you plan on using your vessel over the period please ensure you do so responsibly and with consideration for others. You should also ensure that you are carrying the required minimum safety equipment. Random checks of vessels, including safety equipment carried will be conducted at ramps and at sea. Tasmania police can also random breath test vessel owner and operators with a 0.05 limit applying on the water just like the road. Additionally, one person on your motor boat must possess a speed boat licence and the boat is required to be registered. Please find below a list of safety equipment for your motor boat.

- All passengers in a vessel under 6m must wear an approved life jacket whilst the boat is under way
- Children under 12 in any vessel must wear an approved life jacket whilst the boat is under way
- Carry an auxiliary method of propulsion (i.e. oars or second motor)
- A fire extinguisher
- A bailing bucket
- Anchor and chain
- Flare kit (not required for smooth waters) consisting of a minimum of 2 x orange smoke flares and 2 x red flares (sheltered waters). You will also need 2 x parachute flares if you are going more than 3 nautical miles to sea.
- A marine radio if you are going more than 3 nautical miles to sea

An EPIRB if you are going more than 3 nautical miles to sea

Please ensure to use our roads and waterways responsibly and in consideration of others.

Victorian Bushfire Appeal – Tasmanian service clubs top the nation

Premier David Bartlett last week congratulated Tasmanian Lions, Rotary and Apex clubs for driving the State Government towards a total contribution of \$1 million dollars for the victims of the Victorian bushfires.

“This is one occasion when I can say that I am truly pleased that, someone has extracted every possible dollar from the State.”

In February the Premier announced the Government would commit up to \$1 million dollars in funds to assist victims of the Victorian bushfires. \$250,000 upfront to the Red Cross Bushfire Appeal with a further donation of up to \$750,000 available to match funds raised by Lions, Rotary and Apex clubs, up until the 30th of March.

“It is with great pride I can advise that Tasmanians have once again shown that the smallest state has the biggest heart.

“I believe service clubs are the heart of local communities which is why I wanted to involve Lions, Rotary and Apex in the State Government’s funding commitment.

“In times of human tragedy like the Victorian bushfires, service clubs are there long after the news headlines offering support and helping communities rebuild.

“The involvement of Lions, Rotary and Apex has maximised the amount of money that will flow from Tasmania to those affected by these terrible fires,” Mr Bartlett said.

“Funds have been raised right across the state through events like concerts, auctions, BBQs, raffles and fund raising in schools.”

Service organisations are still collating advice from all their clubs, however preliminary figures are:

Rotary - \$520,000
Lions - \$316,000
Apex - \$ 50,000

Final figures are expected by the end of the month.

“It is this sort of effort that makes me proud to be a Tasmanian.

“To all involved - from the service clubs who have put on events and collected the funds to the individuals who have donated – a big thank you,” Mr Bartlett said.

Cataracts lead new surgery drive

Health Minister Lara Giddings announced last week a \$2 million program to remove cataracts from the eyes of an additional 1,002 Tasmanian patients by the end of August, clearing long-wait cases from the list.

Ms Giddings said the cataract surgery surge would spearhead a drive to clear long-wait cases from elective surgery waiting lists, complementing the elective surgery improvement program already in place.

“This is Tasmania’s Health Plan in action, and as Fred Hollows said, the gift of sight is the gift of life,” Ms Giddings said. “The \$2 million cataract surgery program will enable the completion of an additional 437 cataract procedures through the Royal Hobart Hospital, 325 through the Launceston General and 240 in the North West.

“The RHH will deliver the additional procedures by increasing the volume of surgery contracted through private hospitals as well as within the hospital.

“The North West Area Health Service is increasing the number of cataract sessions at the Mersey Community Hospital to provide an extra 20 cases a week for 12 weeks.”

Ms Giddings said the additional 1,002 procedures would remove all long-wait cases from the cataract surgery waiting list and significantly reduce the extent of the list overall.

“The aim is to not only reduce the cataract waiting list, but to keep it down.

“With our ageing population it would not be possible to eliminate the waiting list completely, but the ability to see with clarity is vital to the capacity to enjoy life and to reduce the risk of falls and the need for further surgery.

“We want to see the list as low as possible and the wait for surgery as short as possible.”

Ms Giddings said the State Government was committed to keep working with the State’s hospitals to make inroads into the numbers of Tasmanians waiting longer than clinically recommended for their operation.

“The treatment of emergency and urgent cases will continue to be the number one priority for all of our hospitals.

“What’s needed is continued improvement in the capacity to provide less urgent elective surgery within appropriate time frames. Last year our hospitals increased the total number of elective surgery admissions by 15% to almost 16,000. That included more than 2,000 additional cases funded from the Tasmanian Elective Surgery Improvement Plan and the Commonwealth Elective Surgery Initiative across a wide range of surgical procedures.

“However, while the additional surgery was targeted at long-wait cases, at the end of February there were still 2,501 Tasmanians on elective surgery waiting lists who had been waiting for surgery longer than a year.

“That is outside the clinically-recommended time frame and the Department has been working with the hospitals on a strategy to, by the end of this year, offer an operation to as many as possible of these long-wait patients who are ready for care.

“That does not mean everyone who has waited longer than 12 months will be offered an operation because there will always be some patients who are clinically assessed as not ready for surgery - because for instance they may require further management of a pre-existing condition.

“As with the cataract surgery initiative, the long-wait program will not be a one-off.

“It is our goal to ensure that no Tasmanian patient assessed as ready for care has to wait longer than 365 days for an operation.”

Community forum on aerial spraying held in Launceston

Here follows a brief note on the community forum held on 26/3/09 in Launceston on the adverse impacts of aerial spraying of pesticides in water catchments in Tasmania (most of Tasmania either is or was a water catchment!).

Approximately 350 folk came and heard first of all from Neil Graham (Western Rivers Preservation Trust) who painted the picture of living in rural Tasmania and being involuntarily subjected to overspray from plantation pest management operations.

Professor Tyrone Hayes (a Professor of Integrative Biology at Uni of California, Berkley) who visited Tasmania in 2007 and was entreated to return, has extensively studied the effects of triazine chemicals on amphibians, and he updated us on the current research – including endocrine disrupting and multi-generational effects - which was compelling and disturbing, with clear implications for adverse health impacts on animals including humans.

Jo Immig launched (with great success) the NTN booklet 'The Threat of Pesticide Spray Drift' which will allow the compilation of a national database of adverse events and should enable the NTN to 'persuade' the Federal and State Governments to fulfil their duty of care and at least take some action to adequately protect health from the effects of pesticides moving away from where they are supposed to be and ensure non-contaminated air, soil, water, food, animals and ourselves!

Anthony Amis (FOE) gave a great talk on his work on the appalling state of waterway contaminations (stats incomplete due to lack of adequate monitoring – and that is being kind) in various States over the past 10 years or so.

And Pete Godfrey, resident of Golden Valley, and responsible citizen gave a spirited overview of his 'struggles' with the authorities – Federal and State – in attempting to prevent overspray and gross contamination of waterways and his immediate surroundings!

Questions came thick and fast- a resolution was passed that demanded an end to the aerial spraying of pesticides in Tasmania, supported by a petition - a good meeting and thanks to all the speakers, the MC Bob McMahon who did a sterling job, and all those folk who were part of the extended team!

On Friday 27/3 at the clinical school Hobart, Tyrone was joined by Dr Matt Landos, a fish veterinarian and a honorary lecturer and associate researcher in aquatic animal health at the University of Sydney, faculty of veterinary science, who has been studying deformed and fitting fish larvae in the Noosa River and in fish hatcheries beside macadamia plantations. He has proposed that these effects on the fish are due to the effects of exposure from pesticides (at below detectable levels) in waterways. The implications to environmental and human health are enormous. They both presented at the grand rounds at the clinical school.

All in all a great couple of days and thanks again to NTN and 'the team' and especially to Tyrone Hayes and Matt Landos.

Review of Danish seine fishery management

The Tasmanian Government has warned people considering investing in the Danish seine fishery that management arrangements for that fishery may change.

The Danish seine fishery is a small component of the commercial scalefish fishery that operates predominantly along the south-east and north-east coasts, targeting flathead and whiting.

The Minister for Primary Industries and Water, David Llewellyn, said that licence holders considering further investment in the fishery are advised that there will be a review of the management arrangements for the Danish seine fishery.

"All management arrangements for the Danish seine fishery will be reviewed. Licence holders are advised that changes to the current access arrangements may be implemented as a result," Mr Llewellyn said.

"If changes are made, historical 'catch and effort' information may be used to allocate levels of ongoing access rights among eligible licence holders."

Catch and effort information recorded and submitted to the Department of Primary Industries and Water in the Scalefish Fishing Record Book after 1 March 2009 may not be considered in the event that such an allocation results from this review.

Furthermore, any investments made in fishing equipment after 1 March 2009 may not be considered if prior investment is used to determine future access.

"This review is not being driven by stock sustainability concerns," Mr Llewellyn said.

"It is about delivering on sustainability objectives more efficiently and providing greater certainty for licence holders. The review will investigate alternative ways to manage catch and effort, including finer scale spatial management. It also will review the transferability restrictions of licences."

Mr Llewellyn emphasised that the warning did not pre-empt any future management measures and that all options for the management of the fishery will be considered.

The review will be undertaken as a separate process from the current Scalefish Review. Licence holders, peak bodies and other key stakeholders are being advised of the review process.

Road Safety Levy builds safer Tasmanian roads

The Minister for Infrastructure, Graeme Sturges, announced recently that the Road Safety Levy was allowing the State Government to build safer infrastructure and save lives on our roads.

The road safety levy was introduced on 1 December 2007 to provide extra funding for road safety initiatives under the Tasmanian Road Safety Strategy.

“The levy is applied directly to road safety initiatives that have been identified through research and expert advice as most likely to reduce the level of serious casualty crashes.” Mr Sturges also said key initiatives funded by the levy included:

- Installation of 21.5 km of Flexible Safety Barrier on Tasmania’s major highways and arterial roads (at an average cost of \$120,000 per kilometre).

- Dollar-for-dollar funding for councils to undertake traffic calming treatments in shared urban spaces.

- The roll out of Electronic Speed Limit Signs at schools. A total of 700 signs are due to be installed at around 240 schools across the State by 2011 (a \$6 million investment).

- Installation of motorcycle safety infrastructure, including ‘stack cushions’ and ‘rub rail’.

- Demonstration and trial of safer default rural travel speeds in Kingborough and Tasman Municipalities.

- Reforms to the Novice Driver Licensing System focused on creating safer young road users. This year will see the extension of the minimum learner period from 6 to 12 months, an increased focus on the importance of supervised driving hours and a second practical assessment.

- New mandatory safety standards for the Government vehicle fleet which, in turn, enables the Tasmanian community to purchase second hand fleet vehicles that benefit from additional safety features.

- A public education campaign on choosing safer vehicles.

- A trial of innovative technologies: a wet weather warning system at Constitution Hill; vehicle activated signs at Mount Pleasant interchange; and alcohol interlocks.

“The road safety levy gives us extra funding we need to make our roads as safe as possible for all Tasmanians,” he said.

Mr Sturges said that a lot had been achieved in the first year of the Levy and that there would continue to be a delivery of major projects.

“Unfortunately, 2009 has already seen a tragic loss of lives on Tasmanian roads.

“The State Government, through the levy, will continue to do all it can to build safer roads, but every road user has a role to play in road safety.

“Too many people are still not taking their responsibility to be safe on the road seriously enough, and it is costing lives.

“Every life lost leaves behind shattered families, friends and communities.


“As I have done many times before, I call on all Tasmanians to do their part and drive safely for their own sake and that of other road users,” Mr Sturges said.

I am contactable by phone, email, letter or on site, and value whatever you have to say. Please take time to help improve our services so we can work towards meeting your needs.

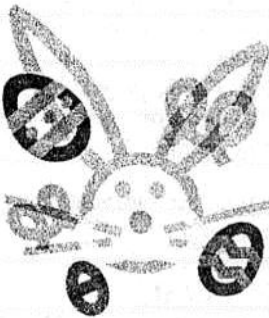

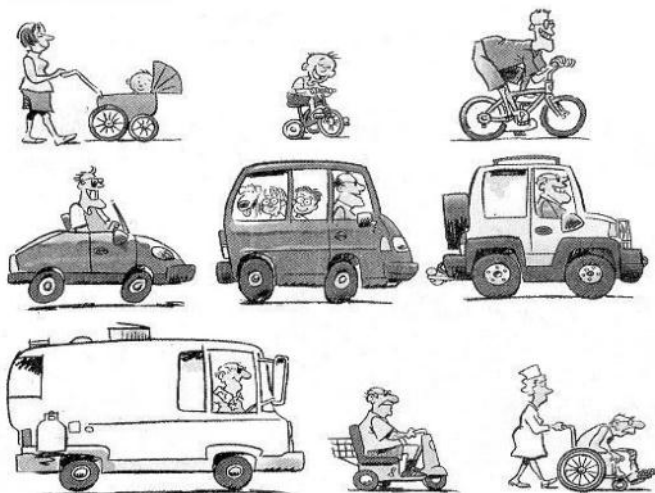

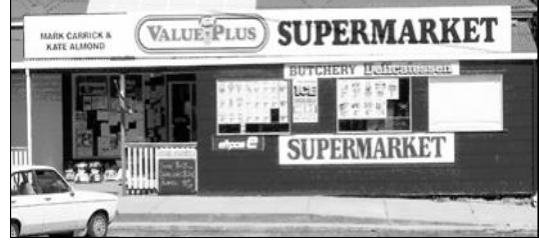
