## A LITTLE BIT OF HERITAGE: Jim Haas "Killymoon"

With European settlement of Tasmania dating back to 1803, the State has an abundance of beautifully designed Georgian structures, most of which were built with convict labour, leaving no doubt that many of these "misguided" souls had unbelievable building skills.


In the Fingal Valley we have a number of buildings dating back to the 1840s with, perhaps, the best examples of Georgian architecture being "Bona Vista" at Avoca and "Killymoon", ten kilometres west of St Marys on the Esk Main Road. Although heritage listed, both properties are privately owned and not open for public viewing.

According to the census of 1842 both buildings were unfinished, but completed by the 1848 census. Also the original owners, Simeon Lord of "Bona Vista" and Frederick von Steiglitz of "Killymoon" left their properties within ten years or so of the completion of their homes. But, it seems, it was the latter who played the more significant role in the development of the Fingal Valley.

Frederick Lewis von Steiglitz was born in Ireland in 1803. Along with three of his brothers he immigrated to Van Diemens Land on board the ship "Lion", arriving in Hobart Town on the 7<sup>th</sup> August 1829. Frederick received a grant of 2000 acres (800 hectares) which he took up on the Break O'Day River and named the holding "Killymoon".

Soon after Frederick arrived in Van Diemens Land he met and fell in love with Catherine Christiana Ransom, nee McNally. Catherine was the widow of former convict boat builder and publican of the Royal Oak Hotel at Green Ponds, which is now Kempton.

Frederick and Catherine were married in 1830 and after several years Catherine, along with her son, Thomas Ransom Junior and an adopted daughter, moved to "Killymoon" where Thomas was soon to take over the neighbouring property of "Millbrook".



Around 1840 Frederick began to build his mansion. It has been suggested that the "Killymoon" homestead was built after the style of Killymoon Castle in County Tyrone, Ireland and that the architect and artisans responsible for the construction of Clarendon House on the Nile went from there to "Killymoon". The main points of similarity between these two elegant Tasmanian residences are the massive chimneys with their very small corner towers.


"Killymoon" homestead is a three storey building, two of which are above ground and the basement is mostly sunk below the level of the surrounding gardens. A feature of the homestead layout is the magnificent outbuildings surrounding the yard, in particular the coach-house with its quaint tower and farmyard clock. Also a point of interest is the two pairs of large iron gates with one pair guarding the entrance to the property and the other pair guarding the stable yard at

the rear of the homestead. It is recorded that the gates were made in Ireland, shipped to Van Diemens Land, unloaded onto the beach at Falmouth, some twenty kilometres away, and carted from there to "Killymoon" by bullock wagon.

By 1841 Frederick von Stieglitz had increased his holding at "Killymoon by another 3,000 acres (1,200 hectares) and was made a Justice of the Peace. In 1857 he was elected as Fingal's representative in the first Elective Council. Sadly, however, in the same year his wife Catherine died, changing Frederick's life forever. A year later in 1858 he sold "Killymoon to his stepson, Thomas Ransom Junior, for £30,000 and returned to Ireland where he resumed his father's title of baron and married Hester Anne Backer in 1859. He died in 1866 aged 63 years.

"Killymoon" remained in the Ransom family until the early 1990s when Charles Ransom died and the property was sold to Graeme Cowley. Since then the property has had two more owners, Eric Dare and the current owner Tim Rhodes who, to his credit, has undertaken an extensive restoration program on the old homestead.

I'm sure if it were possible for Frederick to visit his elegant Georgian mansion today he would find tranquillity strolling the gardens and watching the Break O'Day River meander by. He would also be satisfied that after 160 odd years it still stands tall and proud in a setting of grassy plains and stunning mountain views that could only be found in our magnificent Fingal Valley.





#### Letters to the Editor

Dear Editor.

Readers may have seen the "Today Tonight" programme on Monday night, 16th November, regarding concerns about radio frequency emissions from mobile telephone towers situated in residential areas.

The community is advised that following an earlier rejection by Council of a request for a 200' high tower to be erected behind the football club rooms on St Marys Recreation Ground, and a second rejection by Council of an application for the tower to be located at the town entrance opposite the Railway Station, and a third rejection for the tower to be erected on the Recreation Ground behind the old Fire Station building near the 8th fairway, it has now come to light that a permit has been granted by Council officers without further reference to the community or Council for the tower to be placed on the Recreation Ground next to the old Fire Station, close to the new camping grounds and toilet facilities.

The proponents of the application rejected an offer of land by a landowner further down the valley on the grounds that it was too far from the town centre, apparently do not consider that co-siting at South Sister or Harefield Road with other towers is acceptable, and have not specified the 5 other sites originally identified by them as potential sites. The Planning Scheme prohibits a sub-division of land in the Natural Resource Zone for a utility (the tower) and a lease over 10 years is a sub-division. However, it is being argued that as the lease will now be for less than 10 years with an option for a new lease, it is not a subdivision. The original proposals were all for a 20 year lease, and it could be considered that the proposed shorter lease is a device to overcome the scheme provisions.

Location in a Sport and Recreation ground, next to a golf course, next to a camping area, opposite nearby houses and a school does not seem to be the optimum location for the community, although it minimises road and power connection costs to the company. Council recently rejected a motion to amend the Precautionary Principle to consider possible risks to human health and safety in considering development applications. Council has no Telecommunication Location Policy.

There are issues about this process that raise concerns. David Clement,

Dear Editor.

I had no wish to make this issue a public matter, but a very pointed remark, "I didn't see you at the Remembrance Day Service", made to me by someone associated with the RSL, requires a response.

I am one of a group of local residents who came together as the "St Marys Memorial Service Association" to organise the 2009 ANZAC DAY and the VIETNAM VETERANS/LONG TAN DAY 2009 services at St Marys, as the RSL felt unable to do so.

In an email of 30th October to a member of the group, the President of the St Helens -St Marys RSL demanded that "the RSL will be able to conduct the St Marys (Remembrance Day) Service at the St Marys Cenotaph without any disturbance or disruption by the St Marys Memorial Services Association".

At 11.00 on the 11th November, in our garden, I remembered my great uncle who lost his leg in WW1, I remembered my parents who were in a German Concentration Camp during WW2, my father in-law who fought in New Guinea, my Aunt whose home was bombed in London, and I remembered my early childhood under German occupation in Jersey and that the first words I learned to read were "Achtung! Minen".

Remembrance Day is a day of both personal and general remembrance by people of the wars and conflicts of the past and the present.

Such remembrance does not require a particular place, other people, or an organised service, and is not owned by any organisation - Remembrance Day identifies a particular moment when we all, as individuals, wherever we are, stop our daily lives and join together in the act of remembrance, even if not congregated together.

Organisational thuggery and the "insolence of office" is what I have fought all my life, and it is timely to remember that it can exist in our own community, and not just within the enemies that we have taken issue with over the years.

**BINALONG BAY OLD CAMPING GROUND** not to proceed with a development at the Old Camping Ground until a comprehensive town plan for Binalong Bay has been prepared after extensive consultation with the community **LOST 5-3**





Cllr Clement moved a motion seconded by Cllr Johns that there be no development at the "Old Camping Ground" in Binalong Bay without community consultation and that Council receive the petition from the residents. **Motion lost 5 to 3.** 

Cllr Johns moved that a copy of the full correspondence requesting and giving legal advice opinion be provided to Councillors at the same time the matter is discussed.

#### Motion lost 6 to 2.

Cllr Clement moved, seconded by Cllr Johns that a fixed proportion of rates raised in an area are spent in that area and that this is considered in the Budget deliberations. **Motion lost 6 to 2.** 

A rate remission on the Boat ramp in Ansons Bay is granted after a lease is signed by the Dept of Tourism, Parks.

A rate remission on the Boat ramp in The Gardens was refused...

A rate remission for Forestry Tasmania Leases for weather research was granted moved Cllr Clement seconded by Cllr Johns.

A motion to allow free admission to the Waste Transfer Stations was granted. This means that over the Australia Day Long Weekend you are able to dispose of bulky items and green waste (not domestic waste) for free.

A possible takeover of a section of Lehners Ridge Road by Forestry, was withdrawn till Council sights the signed contract.

Council decided that Wrinklers Drive be assigned to the sub division running off Scamander Ave.

Council decided that Sunrise Court be assigned to the cul de sac running off the major street, Wrinklers Dr. in the new sub division near Wrinklers Lagoon.

In the General Manager's report, a motion was moved by Cllr Clement, seconded by Cllr Johns that the report be received and arising from that report that Council requires a particular report from the St Helens Tourism Precinct Committee outlining its composition, authority and functions, as there are certain Councillors and Council Staff on this committee. #### Changes in the way we Communicate

It's a bit hard to keep up these days with all the changes that are taking place, particularly in the world of communication.

Once we had Mail, Telephone, Radio & TV, Newspapers as our communication devices. It was acceptable to post something to England and take 6 weeks to arrive or post letters to New Zealand that never arrived. We thought the introduction of Fax replacing a Telegram might help speed our communication up. The first fax machine was invented by Scottish mechanic and inventor Alexander Bain in 1843 but didn't gain popularity until 1980. (Very slow in the uptake of this communication method)

Radio began around 1913 but came under the control of governments because of security reasons during the First World War. Radio began in Australia professionally with the opening of station 2FC in Sydney on the 1<sup>st</sup> of July 1923.

The TV was an okay form of communication to have easy access to the latest news. Mainstream professional television was launched on 16 September 1956 in Sydney.

The downside of these forms of communication is the fact that only a couple of people hold the licenses to broadcast TV, radio and print newspapers so we are force fed by this mass media, what they believe is good for us.

From the introduction of Television to the beginning of Internet in 1990's after some years of trials stemming back to 1960 we have a void of new communication methods

The Internet soon replaced Fax & Telegrams with Email. In many ways the use of the telephone has been reduced by the use of Email. Gradually we are seeing Internet devices such as Youtube replacing TV. Many groups are utilizing the Internet to broadcast live vision of sporting activities that are not commercially viable or go against the particular media mogul's genetic engineering brand. We had in place an agreement between the Television media owners and Telstra that fast broadband would be held back for 6 years to assist the TV media to keep their market share as a communication media.

There is talk of a fast broadband rollout soon. This form of broadband will enable speeds that will stream across the Internet live vision to the standard we currently view TV. This means that we will have thousands, millions of people or groups that publish TV via the Internet. That in itself is a brave new world.

I had an email the other day from someone wanting me to join a new communication method called Google Wave. It's a mixture of email, chat, interactive white boards etc. etc. This along with Facebook, Twitter and Blogging is once again increasing the methods and complexity of communication. With fast broadband, video conferencing via the Internet will be a common activity.

It's easy to get a bit confused and worried about all this and to just toss the baby out with the bathwater, pretending it is all irrelevant nonsense or to stop the flow of electricity and go back to the Carrier Pigeon. In a way it is creating another generation gap. Young people just can't get enough of all these new communication methods, online games, music videos or Youtube.

In many ways if you don't communicate with your children via SMS, Facebook or Email you will probably lose contact with them, especially as they leave the district to pursue careers in the city.

I was in the St.Marys Online Centre the other day and Mum in her 40's and 2 daughters in their 20's were all updating their Facebook accounts. There really is no generation gap I have seen people in their 50's recently who have no computer skills whatever begin to bridge the gap and within a short time have become versatile with computers and now happily emailing close relatives around Australia.

I imagine the same problems occurred when the Telephone started, when TV & Radio began. It is a matter of change, the older we get the less we like change but that doesn't stop change from happening. Change seems to be happening faster now, new devices, new programs, new methods of communication, just a matter of accepting or rejecting it. Wind back the clock, turn off the machine, or embrace it. It's up to you but the world keeps spinning around in space even if you don't feel or see the wind of Change.



#### St Marys Police Report

Since my last report Police within the St Helens Division have again been kept busy with attendance at road crashes, crime scenes and reports of damage to property. To the parents of these young persons I would ask the question, "Do you know what your child is doing now?"

#### CRIME REPORT

St Marys police recently attended two reports of damage to property in the business area of the township. It appears the damage was the result of wanton stupidity as the damage caused provided

the offender the opportunity to steal property close by, however this did not occur. As a result of investigations conducted to date, members of the public have assisted police with inquiries and the offender should be identified and charged in the near future.

I am pleased to report that three of the pins have been returned, with "Santa Claus" placing them at the front door of the St Marys Police Station and subsequently being returned to their rightful owners at the Golf Club. On behalf of the members of the club, thank you "Santa" for your consideration.

St Marys police also received a complaint of assault against a Seymour woman resulting in a male person being charged with common assault.

#### TRAFFIC REPORT

From a policing perspective we are well and truly into the motoring "tourist" season. As a result St Marys police have attended two separate incidents in recent weeks involving interstate or overseas tourists.

The first crash involving a young couple from Melbourne occurred when their vehicle failed to negotiate a sharp right hand corner on the Tasman Highway in the Chain of Lagoons area. As a result the driver lost control, causing the car to drift sideways across the roadway before entering a paddock and hitting a tree. Fortunately neither person was injured, however their little hire car was worse for wear and had to be towed from the scene.

The second more recent crash involved a young couple from Switzerland when their vehicle failed to negotiate a corner on the Tasman Highway between the bottom of St Marys Pass and Scamander. As a result the driver lost control and the vehicle running off the roadway, hitting an embankment and rolling over. Once again neither occupant was injured, however both were extremely lucky. Unfortunately their hire car did not fare as well and appeared to be a write off.

#### MARINE SAFETY

The November long weekend has been and gone, however now that the rock lobster season for recreational fishers is open a further reminder of exercising care and caution when on our waters for the entire season. If you plan on using your vessel over the period please ensure you do so responsibly and with consideration for others. You should also ensure that you are carrying the required minimum safety equipment. Random checks of vessels, including safety equipment carried will be conducted at ramps and at sea. Tasmania police can also random breath test vessel owner and operators with a 0.05 limit applying on the water just like the road. Additionally, one person on your motor boat must possess a speed boat licence and the boat is required to be registered. Please find below a list of safety equipment for your motor boat.

- All passengers in a vessel under 6m must wear an approved life jacket whilst the boat is under way
- Children under 12 in any vessel must wear an approved life jacket whilst the boat is under way
- Carry an auxiliary method of propulsion (i.e. oars or second motor)
- A fire extinguisher
- A bailing bucket
- Anchor and chain
- Flare kit (not required for smooth waters) consisting of a minimum of 2 x orange smoke flares and 2 x red flares (sheltered waters). You will also need 2 x parachute flares if you are going more than 3 nautical miles to sea.
- A marine radio if you are going more than 3 nautical miles to sea An EPIRB if you are going more than 3 nautical miles to sea

Please ensure to use our roads and waterways responsibly and in consideration of others.


