HEALTH

Not so long ago in the Fingal Valley we were blessed with two doctors, both of whom were permanent residents and very much a part of the local community. If you needed a doctor you made an appointment and within a day or so you entered the surgery where you sat down with someone you had known for years and looked on as a friend, or even part of the family.

Like many country areas in Australia, however, times have changed and where two doctors once shared a heavy work load, it is now left to just one. As things are here in the Valley at the moment we can only imagine the pressure one doctor must be under and whilst we have a number of very good doctors coming and going, one can understand why they would not want to stay permanently when they are continually in demand.

But when we do complain about having to wait a little longer for an appointment, or see a different face every time we visit our doctor, spare a thought for our ancestors who up until 1879 did not have a



doctor of any kind stationed in the Valley. Before then medical services were left to midwives and a bush nurse or two. Although, with Campbell Town being the first county town in Tasmania to open a hospital in 1855, a doctor from there did visit the Valley on rare occasions.

For many years the local council and community leaders lobbied vigorously for a permanent doctor in the Fingal Valley, but it wasn't until a Doctor Hopkins was recruited from Victoria, some fifty two years after the first settlers arrived, and moved into the Superintendant of Police's house at Fingal were their endeavours rewarded.

But his workload was enormous, too, having to cover the whole Fingal Valley from Avoca to St Marys, plus outlying areas like Mathinna and the St. Paul's Plains and his only means of transport was a horse and dray. But Dr. Hopkins and those who followed him were a Godsend; at least the Valley had a doctor of their own and that in itself gave great comfort.



The next community health issue was the lack of medical facilities and a push for a hospital began. Campbell Town or Launceston was a long way in those days and they didn't have а modern ambulance manned by caring, well trained volunteers transporting the sick or injured on bitumen roads.

Our ancestors were a

lot and, although it took many years to achieve, the Government was finally persuaded to build a hospital at St Marys. The foundation stone, which is still set in the Medical Centre wall today, was laid by Robert William Legge of "Cullenswood", the grandfather of our current Mayor. It was laid on the 4th September 1927, with the St Marys Hospital officially opened on the 25th April 1928.

The Grand Opening was a momentous occasion attended by dignitaries and locals alike, all celebrating the beginning of a new era in health for the Fingal Valley. St Marys Hospital went on to become a country medical facility second to none. It served the people through the Great Depression and World War Two. It healed the sick, treated the injured, delivered the babies, comforted the depressed, performed minor surgery and cared for the elderly. Despite a hiccup or two along the way, it has grown in stature and strength making it a country medical facility of which we can all be proud.

So when we walk through the doors of our Medical Centre today have a look around and appreciate what we have and give a note of thanks to those who have fought over the years, not only to build it in the first place, but to keep it open in its current state. Perhaps we can also spare a thought for our early settlers to the Fingal Valley, many of whom died because medical facilities of any kind were just not available in their day.

In the years I have been on Council I have always acted with integrity. Carefully studied all motions put before me and acted accordingly for what I thought was right. Most of my fellow Councillors exercise their rights and if the end result is a 6 - 2 then democracy prevails.

In reply to "Scamander Resident" (Voice 8 October), the way which households are charged for sewage removal is unfair- there should be the same fixed flagfall charge for all households within the same Sewage district, and those who create more sewage should pay more. Although Council's are no longer responsible for sewage, I would move for a newly elected Break O'Day Council to lobby Ben Lomond Water on behalf of residents throughout the municipality to move away from the system inherited from the previous Council to a flat charge system.

The unfairness is not that Scamander ratepayers pay more than St Marys, but that some Scamander households pay more than other Scamander Households, because Council previously recovered the cost of sewage removal by a rate based on the value of the property and not by a standard average charge. Ben Lomond Water is continuing this system.

Water in the BOD is charged on the basis of a fixed cost (a flagfall charge) plus a consumption charge for water used. Why not the same method for sewage? It is simply a matter of recovering the costs of (1)supplying clean water in and (2) removing grey/black water out. I tried to get Council to adopt a standard average sewage charge per household, plus a sewage production cost (based on a % of water consumption), but was unsuccessful.

Sewage charges in the St Marys Sewerage District, and other Schemes, will also vary between households due to differences in the value of the property; some St Marys residents will pay more than some in Scamander, and vice versa. A difference in the <u>minimum</u> cost between Scamander and St Marys simply reflects that it costs more to provide sewage removal per connection in the Scamander Sewerage District than in the St Marys District. Operating costs, maintenance and financing costs, and the provisions made for future expansion vary according to the individual circumstances, age and size of each system.

Our casualties, Lachie and Kerby, showed great bravery and calm amidst showering glass, while the hydraulic Jaws of Life cut through the vehicles to free them.

Sharing of skills and regular training sessions, ensure that in an emergency, our volunteers are prepared for any eventuality.

Forest EcoCentre radio show gives fire caution

Forestry Tasmania's fire incident control room at the Forest EcoCentre became a temporary radio studio last week when the ABC Drive program was presented as

an outside broadcast. Presenter Roisin McCann interviewed several Forestry Tasmania workers about their experience in



fighting fires and managing Jamie Haas "on air" with ABC announcer Roisin McCann.

State forests for fire safety as part of the station's bush fire preparedness day.

"We know that Forestry Tasmania plays a vital role in fighting fires and of the agencies involved with the Tasmania Fire Service and Parks and Wildlife it is some times overlooked," Ms McCann said.

Along with a helicopter flight over some State forest, she was given a tour of the Mount Horror fire tower by fire spotter Les Harper.

Long-time forestry worker Kerry Wakefield explained the advances in technology that have made fire fighting much more efficient over his more than 30-year involvement.

"There was a lot of hard manual work back at the start. There's still some dirty, difficult labour involved, but with helicopters, GPS and much improved communications it's a much more exact science these days," Mr Wakefield said.

Fire management officer Jamie Haas emphasised the importance of reducing fuels to minimise risks of wildfire. He was involved in a burn at Diana's Basin last week to help complete a buffer around the St Helens-Scamander area.

The buffer concept has been planned by a committee involving community and industry representatives along with the Fire Service, Parks and Forestry Tasmania.

"I know some people are inconvenienced by smoke from reduction burns, but we have to try to achieve a balance. I think most people would agree that a few days of smelly

washing is worth putting up with for long-term peace of mind about potential, destructive wild fires," Mr Haas said.

The wet winter and spring has resulted in a quiet start to the fire season, but Bass District Forest Manager Peter Bird said people still needed to be cautious.

"Once the hotter and drier conditions arrive it won't take long for the extra growth that has been promoted by the rain to become highly flammable.

But rest assured, with all staff required to be fire duty ready, we will be prepared."



Owners and occupiers of property in the Municipality are reminded that over the coming weeks abatement notices, where considered necessary, be issued for the appropriate clearing of fire hazards. Under the *Local Government Act 1993*, Council is required to issue Fire Abatement Notices that calls for the removal of the hazard within a specified time period. Failure to remove fire hazards in the specified time could lead to compulsory clearance at the property owners' expense.

Council seeks the cooperation of owners and occupiers in ensuring that their property does not constitute a threat during the coming months.
