

A LITTLE BIT OF HERITAGE: Jim Haas "Amazing Grace"

Without a doubt the most popular Christian hymn sung today is "Amazing Grace". Almost every Gospel singer in the last hundred years or so has recorded a version. But whether it is sung by famous artists or as a hymn in church by a group of amateurs, the lyrics and tune have a way of uplifting the faithful and stirring the souls of even the non-believers.

For those of us who love the hymn, we all have a favourite version and whilst modern singers like Whitney Houston, who, with her strong voice, sings it well; I think the Elvis version from the sixties takes a lot of beating. But, then, you can throw in Burl Ives, Nana Mouskouri and Willie Nelson, all of whom have very different voices, but the feeling they put into this song shows their commitment to their faith and the message the song portrays.

In the Book of Common Prayer most of the hymns go back to the sixteenth Century and beyond. Amazing Grace, however, is a little more modern; it was written by a remarkable man by the name of John Newton sometime between 1760 and 1770.

John Newton was born in London on the 24th July 1725. He was the son of a merchant sea captain and at age eleven joined his father at sea. In 1744 he joined the British Navy, but found conditions on board the man-of-war ship *H.M.S. Harwich* intolerable and deserted. He was soon recaptured, flogged and demoted from midshipman to common seaman and at his own request was exchanged into service on a slave ship. Around 1748 he was taken in by an old sea captain friend of his father's and under his guidance, soon became captain of his own ship.

Although Newton had some religious instruction as a young boy he had long since given up any religious convictions, and for some years worked entirely in the slave trade. On a homeward voyage, however, while he was attempting to sail through a violent storm, he experienced what he later referred to as his great deliverance. He recorded in his journal that when all seemed lost and the ship was about to sink he cried, "Lord, have mercy upon us.". Later in his cabin he reflected on what he had said and believed God had guided him and his ship through the storm.

After that day Newton became a strong believer and although he continued in the slave trade for a few more years, he made sure the slaves under his care were treated humanely.

In 1755 Newton suffered a serious illness which ended his seafaring days. But by then he had begun to educate himself by learning Latin, among other subjects. In 1760 he moved to Liverpool and became friends with George Whitefield who was a prominent leader of the Calvinistic Methodist Church.

Newton became an enthusiastic disciple of Whitefield's, which soon led to him deciding to become a minister and applied to the Archdeacon of York for ordination. His first application was refused, but he persisted in his goal and was eventually ordained by the Bishop of Lincoln and given a small church in Olney, Buckinghamshire. His sermons, like his hymns, were inspiring and the little church soon became so crowded it had to be enlarged.

With the help of poet friend William Cowper, Newton wrote hundreds of hymns during his years as a minister. Little would he have known that the hymn inspired on the night he first believed, in that horrific storm at sea, would become the most sung hymn of all time.

Although he went blind in his latter years, Newton continued to preach until the very end. He died in London on the 21st December 1807, secure in his faith that amazing grace would lead him home.

I wish to clarify a point. The Local Govt Act 1993 is quite clear that you can only display a political poster when authorised by the candidate.

"Page 18 of the Information for Candidates Issued May 2009 states:

(3) A person, within the relevant period, must not print, publish, broadcast or distribute any electoral advertising that contains the name, photograph or a likeness of a candidate or intending candidate at an election without the written consent of the candidate or intending candidate."

It is also an offence to damage any political poster.

I did not supply, authorise or approach the premises in question to display any of my posters for the December 2009 council elections.

It also beggars belief that a businessman and a figure of authority would condone and treat as "trivial" any matter that contravenes the Law.

I would like to express my dismay that you feel under pressure to cease the "letters to the editor" section of The Valley Voice.

In particular I valued the way you provided a forum for electoral comment from readers across the board while rigorously enforcing the rules imposed by the electoral commission... a tough task not appreciated by many and clearly not understood by a number of potential and actual contributors I suspect, and one certainly not performed with the same rigors by editors of other publications in the municipality.

The election campaign was a fascinating exercise and generally a "clean fight" as far as the candidates were concerned... no mean feat in a small community. Congratulations to the successful candidates. I for one, look forward to a future underpinned by observance of a code of ethics which underlines the communication, transparency and accountability they all promised.

I remain saddened by the attitude/ignorance of some who, in an attempt to shore up the chances of their chosen candidate, committed serious breaches of the ACT (Local Govt Act 1993) as it pertains to the conduct of elections.

Ms Chappell is quite right... it is her democratic right to display the advertising material of her chosen candidate... with the consent of that candidate; to display material without the candidates' consent places both her and the candidate in breach of the ACT...it is not OK to copy something from this, or any other publication for display or distribution during an election.

Ms Peryman is also quite correct, the defacing of any electoral material is a breach of the Act, to deface Councillor McGiveron's poster is just as illegal, and childish, as defacing that of Councillor Johns.

We certainly all live in a small community and feelings frequently run high at election time.. That is why the conditions imposed by the relevant legislation exist, they protect us all by ensuring a level playing field; they regulate the nature, timing and cost of advertising, prohibit anonymous comments (including those written as poorly disguised satire) and prohibit the display of electoral material on crown (or public) land and the defacing of posters.

I am aware that there are those who consider me a little pedantic but I will not apologise for my belief in the democratic process, to live in a society which allows participation without fear or favour is a privilege and with that privilege come responsibility. The Electoral Act protects us all and breaches of it can incur fines or imprisonment.

Thank you for keeping us all on the straight and narrow and keep up the good work.

My letter is a response to one written by David Clement in the VV Dated December17, 2009 in which he complains about visual pollution and multiplicity of speed signs within towns. A few years ago in his personal campaign to reduce speeds within towns, Mr Clement without authorisation, undid the 60KMPH speed sign within the township of St Marys and placed them upside down. Speeds have since changed which now include 50KMPH signs, but he continues to complain that now we have the changes, too many of these signs exist, obviously some people are never satisfied!

There are a couple of things he asserts about this sign, firstly he claims his property is number 1 Gray Road, one only has to look in the telephone book to discover his advertised address is number 11 and has been for years. It is also quite ironic that this so called name and address identification sign was removed immediately after completion of the election.

These are just some examples of his behavior which can only be described as personal stunts which in my view does nothing to enhance the reputation of this town or its residents.. I agree with the view of Harry Veldums who in the same VV stated that some of the articles and letters printed recently can only cause division and destructive influences within our town. Be careful when looking for the truth in what you read.

It has taken me 14 years of hard labour, loss of my right hip, and my eye sight, to finally buy my little 4 acre bush block. For over 9 years I had searched Tassy seeking the perfect place to initiate my driving desire.



For the past 5 years I have been slowly building Mermaids Retreat. It was to be a teaching and respite centre for children with disabilities, who are sick and traumatized. A foundation was to be set up and placed in perpetuity.

I have just returned from visiting Appin Hall, started by singer Ronnie Burns and wife Maggie. It was a truly wonderful experience. These children are very fortunate to have such a magical place to experience and come to. They have many years yet to the completion of their goal. (Visit the website: www.appinhall.com) Maggie took me on a grand tour after I had expressed that I had similar intentions. They told me they started totally broke, but with good intent, miracles happened. In just one day \$30,000 was gifted to kick start their goal.


I have been a WWOOF host on Mermaids, and teach Steiner and Rolf D Storl principles of Biology Biodynamics, having been a passionate gardener since 14 years of age. I am an artist/sculptor; my work was on display at e.ScApe. I work in many mediums. I was with the faculty of the School of Fine Arts in Launceston in 1985/6, studying Bronze Techniques and teaching carving.

My role at Mermaids was to teach survival skills, looking after and building immune systems, and have a rotation of visiting Artisans to teach with me. This is hands on in field work, the place to do this is crucial in its requirements. No noise, clean environment, to enable these children to respond quickly.

I was looking forward to a major leap this summer, to getting my main accommodation up; friends had pledged help and materials. Many people in St Marys have known of my venture, however it all come to a halt when the adjoining land was sold, and our only access road up to the old Wescom farm was cruelly taken from us, (pictured) leaving 4 properties with no entrance to their land. My neighbour and I have been driving along and maintaining this road for over 15 years, the other land owners since early 1990s.

Since being given 1½ hours to vacate my property on the 4th October, I have been living in my vehicle, my beautiful Mermaids left to bear the ravages of the heat, no water, vermin, snakes and overgrowth.

My gracious thanks to all the wonderful people who have helped us to try and claim our homes, I am yours eternally. Gratefully, Babs Strainig.



RAIL TRAIL UPDATE

Over the past six months Neil Capill, on behalf of the St Marys Association for Community Development Inc., has been busy researching the possibility of turning the old rail line from St Marys to Fingal into a recreational trail. It is envisaged this would cater for walkers, cyclists and horse riding.

Neil has been in contact with Crown Land, who are the owners of the land, The Department of Sport and Recreation, Break O'Day Council, State and Federal politicians, local business people and community groups, all of whom have given preliminary support for the project.

This, of cause, is a big project and would take a great deal of funding from Government bodies, none of which will even look at an application without a feasibility study carried out by a qualified consultant. The best quote we have on this is \$8,019 from John Hepper of Inspiring Place Consultants, who have previous experience in this particular field. The consultancy fee could be funded through community grant programs, but the first step in the grants process is for the land to be licensed to the Local Council.

Other State Governments, particularly Victoria, have spent millions of dollars turning old disused rail lines into recreational trails. We can only hope the Tasmanian

Government can see the benefits and do likewise.

We all see this project as being a wonderful asset to the St Marys /Fingal communities, both as a local recreational facility and a tourist attraction. As well it has the potential to attract a long term work for the dole program with a full time employee. The process to make it work, however, is rather complex and will take some time to work through.

Neil and his committee are passionate about the project and you can be assured that they are taking each step as it comes, which will hopefully lead to a positive outcome.

Alofa Samoa! was an event hosted by the Falmouth Community Centre Committee, marking the launch of my mission to raise money to help rebuild in Samoa after the devastating tsunami struck the south side of the beautiful islands last September.

It was held on Saturday December 5th and saw the centre come to island life, full of colour, dance, live music and a feast of Samoan food all day and all night. With almost 200 visitors throughout the day, \$2300 was raised – just off a quarter of our \$10 000 aim. This is a great start !

I would like to send out a huge thank you to the many individuals and local businesses who supported this event: the cooks, the musicians, door crew, dancers, cleaners, bar staff, umu (stone oven) / spit makers and keepers, both St Helens supermarkets, St Marys butcher and supermarket, St Marys School catering staff, Falmouth Community Centre crew, video editor, and ALL guests and donators. It has been a very humbling experience being on

the receiving end of such generosity. Fa'afetai lava! Thank you from the bottom of my heart!!

Currently, Samoa is still very much in recovery. Thousands are still homeless and are now using makeshift sites in the hills as their base. In some areas there is still a shortage of fresh water, and many are totally reliant on relief aid. Although by nature Samoans are strong and resilient, for those who were directly effected (some losing up to twenty family members), many are now showing signs of depression and post traumatic stress. Reports say there are not nearly enough counsellors to call upon for support.

Like many other individuals around the globe who are connected to Samoa in some way, I too feel the need to help. I aim to travel to Samoa, with my family, in June with at least \$10 000 to offer direct support to those in need.

My partner, who is an experienced builder, will contribute his professional skills, and the majority of funds raised will be spent on building materials and related building costs. After considerable discussion, we have decided to do this independently of any organization and will hold ourselves accountable to the community and financial contributors in the way of visual documentation and a detailed record of spending.

Fundraising efforts have been going well so far. Recently, I have sent out an 'experimental' text to friends and community asking for a donation of \$5 into the special bank account kindly set up by Healthy Community House, and in turn, urging that the text be forwarded on. I am interested to know if this strategy might see \$1000 raised.



COMMUNITY FUNDING PROGRAM

2009/2010

The Community Funding Program provides grants to communities to improve facilities/programs in their township or to improve the overall amenity of their town. All community groups that represent the ratepayers of their community are eligible to apply for funding.

Projects that will be considered for funding but not necessarily restricted to:

Beautification projects Projects to improve or construct recreation facilities Projects that will improve the amenity of the township/community

Projects that will not be considered:

Any projects on privately owned land or which cannot be freely accessed by all community members Capital Works projects (ie. Footpaths, kerb and guttering etc.)

Eligibility

All community groups that represent the ratepayers of their township/area are eligible to apply for funding. Only local **NOT-FOR-PROFIT** community groups will be given consideration for funding assistance. Preference will be given to incorporated organisations with proven capacity to administer grants.

A detailed submission must be developed, addressing the following criteria:


A little history about St Valentine's Day.

The widely practiced tradition of sending cards, letters, and poems as part of Valentine's Day got a late start in the western world, but the tradition of celebrating the

day has a long history.

The origin of St. Valentine's Day stems from the days of Claudius II in the third century, when a Roman priest named Valentinus was persecuted and imprisoned for helping Christian martyrs. On the eve of his beheading, he wrote a farewell note to his friend, the daughter of the jailer. He signed the note "From Your Valentine." The date was February 14th.

Valentinus' death took place at a time of year when the pagan feast Lupercalia was celebrated. The beheading, which was public, was probably incorporated into the pagan celebration.



As Christianity spread throughout the world, Christian priests began to look favorably upon pagan festivals, turning them into

Valentinus.

Christian celebrations. It is likely that Lupercalia became increasingly associated with Valentinus and his departing message, leading to the eventual popularity of sentimental cards and letters.



Can you imagine what our visitors must think when they come across such things.? I can, and it makes me ashamed to call myself a Valley person when considering this fact.→





I know it is disheartening to put all that effort into your campaign and not get the expected result. However, there are lessons to be learnt and better luck next time.

The Council had two meetings in January, one on the 11th and the other one the 18th. The column I am combining both meetings.

The federal Government has offered a grant called Regional and Local Community Infrastructure Program and this was for project over a million dollars.

There were two projects put forward, one for the Surf Life Saving Clubhouse at Scamander and a swimming pool at St Helens. After some strong debate Cllr Osborne moved that Council was not in a position to satisfy the application guidelines, this was seconded by Cllr McGiveron. Cllr Clement moved an amendment seconded by Cllr Johns that Council make application for a swimming pool. This was carried with only Cllrs Osborne, Legge and McGiveron opposing.

A motion was moved that Council set aside the amount of \$20,000 from the public open space reserve. An amendment was put that this matter be moved into a workshop. Carried unanimously.

Clr Bleaney moved a motion regarding the Crepes Celeste Hawkers License and the conditions placed on this enterprise. Seconded by Cllr Rubenach.

Cllr Clement moved an amendment, seconded by Cllr Johns that the original conditions be reinstated. Carried with Cllrs McGiveron, Schmerl, LeFevre and Legge opposing.

Cllr Clement moved a motion identifying three suitable buildings that could be used as an Arts space, seconded Cllr Johns. Carried unanimously.

A motion for the use of the St Helens Sports Complex to be used for overnight camping, from November till April was raised. Carried unanimously.

A motion to spend \$3200 on the line markings for the Fingal Community Centre was raised. This was carried.

Rate Remissions were approved for-Boat ramp PID 6808334

The Council was advised that there was a vacancy on the NRM Special Committee, however no Councillor was able to fill the position.

The General Manager has called for applications for the position of Community Support Officer – Natural Resource Management (NRM).

The Council debated for meeting times that are night or day meetings, the consensus was that day meetings be kept as they are.

Outreach Worker for the Fingal Valley

Break O'Day be declared a motorcycle friendly municipality

Cllr Osborne moved that Council endorse the proposal for the Break O'Day Health Resource Association in their submission for a grant to extend their premises.

Carried Unanimously.

St Marys Police report

As this is the first report for me for 2010 I would on behalf of all personnel from the St Helens Police Division wish all readers a safe and happy new year. I have for the first time for a very long time enjoyed having both the Christmas and New Year periods off and spent some quality time with my wife and family, whom are now spread all over Tasmania and the Mainland. Many people would not consider or recognise the sacrifice made and the disruption caused, to the family environment of not only police officers, but of all Emergency Services and Health Care workers over the Christmas/New

Year holiday period. I take my hat off to you one and all!

CRIME REPORT

St Marys police recently attended the scene of a burglary and stealing from a shack at Falmouth. A number of forensic samples were obtained from the scene and hopefully analysis of the samples will identify an offender. Other evidence gained at the scene has given police a line of inquiry in the interim period.

Avoca, Fingal and St Marys police attended the scene of a violent street incident at Fingal involving a female victim and other persons. The offender was apprehended after the valuable assistance from members of the Fingal community, resulting in the offender being charged with a series of crimes and offences and being remanded in custody.

PUBLIC ORDER OFFENCES

During the recent Australia Day Celebration weekend St Helens Division personnel and members from the Northern Public Order Response Team performed duty in the St Helens and Fingal Valley areas. I'm pleased to report there were no arrests made, however 14 liquor infringement notices were issued to individuals for consuming/possessing open container of alcohol in a public street. It never ceases to amaze me (as the law has existed for nearly two decades) that people still choose to walk the streets with open containers of alcohol, knowing full well they can be fined. Treasury officials must rub their hands with every L.I.N. issued. It is one the easiest \$120 the government must receive!

St Marys police have received a number of complaints regarding the noisy and nuisance conduct of persons walking between houses around the town or from the local licensed establishment late at night and in the early hours of most Friday's and Saturday's. Not only is this conduct selfish, immature and unacceptable, it will not be condoned by police, with offenders being given zero tolerance, resulting in arrest/charge and a court appearance.

TRAFFIC REPORT

Most readers would have no doubt by now heard of the new laws relating to hooning, excessive speed, noise etc resulting in lengthy periods of vehicle confiscation and large mandatory fines and automatic loss of licence.

Other road safety measures relate to a big increase in the fines for offences relating to the use of mobile phones whilst driving, together with driver and occupants failing to wear seat belts.

Some may say it is revenue raising by government, however in reality Tasmania has languished well behind the mainland states for many years, in the area of penalties for traffic offences.

What has now occurred is that input from all stakeholders together with the Road Safety authorities, whom having closely analysed the crash statistics and identified those offences relating to the crash data and then lobbied the government to have the fines increased in those areas. In my opinion a common sense and justifiable position and one that hopefully will reduce the road toll to a much lower level than 2009.

What is pleasing from a policing perspective is the number of motorists reporting dangerous or unacceptable driving behaviour on the 131444 number resulting in an increase in the detection and proceedings against those drivers responsible.

MARINE SAFETY

Sadly a recent boating accident near St Helens resulting in the death of a 59 year old woman and a pet dog. This matter is now the subject of a Coroners Inquest. Whilst boating is generally an enjoyable experience on most occasions, it is a solemn reminder of the power of the sea and the need to ensure your boat is equipped with the necessary safety equipment.

Tasmania police can also random breath test vessel owner and operators with a 0.05 limit applying on the water just like the road. Additionally, one person on your motor boat must possess a speed boat licence and the boat is required to be registered. Please find below a list of safety equipment for your motor boat.

- All passengers in a vessel under 6m must wear an approved life jacket whilst the boat is under way
- Children under 12 in any vessel must wear an approved life jacket whilst the boat is under way
- Carry an auxiliary method of propulsion (i.e. oars or second motor)
- A fire extinguisher
- A bailing bucket
- Anchor and chain

Flare kit (not required for smooth waters) consisting of a minimum of 2 x orange smoke flares and 2 x red flares (sheltered waters). You will also need 2 x parachute flares if you are going more than 3 nautical miles to sea.

A marine radio if you are going more than 3 nautical miles to sea An EPIRB if you are going more than 3 nautical miles to sea.

Please ensure to use our roads and waterways responsibly and in consideration of others.



Anyway until next time, good hitting and rolling.




