

### A LITTLE BIT OF HERITAGE: Jim Haas "Face Lift at Cornwall Community Hall"

In 1934 a group of Cornwall residents met in the school house to discuss the prospects of building a new community hall to replace the one that had been mysteriously burnt down four years earlier.

Mr George Tickle, an under manager at the coal mine, had researched the project and told the meeting that a building 36 feet long by 24 feet wide, with a stage of 17 feet by 12 feet and two anti rooms, each 12 feet by 9 feet, would cost approximately £225 for materials. However, he went on to say that there was already £30 in hand and Mr Ted Nicholson had kindly donated a piece of suitable land in the centre of town. If families with a working member could have one shilling a fortnight stopped from their pay, the remaining money could be raised in a matter of six months. The proposal put forward by Mr Tickle was accepted by the meeting and after Cornwall Coal Co pledged a donation, construction was soon underway.

The hall was completed by volunteers towards the end of 1935, but it wasn't until March 1936 that a Grand Ball was held for the opening. Before the big event the floor was covered with sawdust, sprinkled with kerosene, left for a few days then sweep up leaving

the floor squeaky clean. Then candle wax was shaved into small pieces and spread over the floor and the kids would have great fun sitting on potato sacks and dragging each other around the floor to rub the wax in. This was all extremely important to enable the floor to be suitable for good dancing.

The big night arrived, local musicians in the Nolans, Stochnetters, Maddens, Broughs and Targetts were all up on stage tuning their instruments. All the locals, dressed to their nines, were joined by people from all around the district, as well as dignitaries such as State Politician Robert Cosgrove and his wife. Everyone was hyped with excitement as the dancing reached great heights. A huge supper was served, during which Mr Cosgrove officially opened the hall. He made special mention of the magnificent community effort that had gone into this wonderful facility.

Following the opening, Cornwall Hall was the focal point of the town. Every week it catered for meetings, band practice, card evenings, fairs, kitchen teas for every local girl who was to be married and the local musicians would play for a dances and concerts. Then there were the sports like badminton and indoor bowls which provided great entertainment for young and old alike.

It's interesting to note that the first Kitchen Tea to be held in the new hall was for a young school teacher by the name of Una Herbert, who became Una Camplin and went on to be a key figure in the development of the Cornwall Community.

But times have not always been easy for the Cornwall Hall. In the early 1960s a dispute broke out between the badminton club and the hall committee. The badminton club claimed that they were the main users of the hall at that time and needed a full size court. The only way this could be achieved was to take out the stage, of which they claimed was never used. Arguments were thrown back and forth, meetings were held with a police presence to maintain order and the town was split in two for months. But finally the badminton club won out and the stage was removed.

In recent years when the current Community Group decided to restore the old building it was realised that the land on which the hall was built did not have a title. This created a can of worms that saw the Group having to trace the families of the original trustees. This was not an easy task when most of the descendents were female with married names. But thanks to Tom Bain from Rae and Partners, the relevant descendents were found and all the legal processes were dealt with. Finally, after 76 years the people of Cornwall became the legal owners of their Hall.

Now thanks to Break O'Day Council who are renovating the toilets for public use, and the Cornwall Community Group who are undertaking to refurbish the rest of the building, the old Hall will have a face lift that, we hope, will eventually bring it back to something like its former glory. Unfortunately, however, a 17 by 12 foot stage is not included in the current budget.

I feel I must reply to Babs Straining letter "A Cruel Indecency"

The access track that Babs refers to in her letter is not a legal road reserve (surveyed access road). This track was put in place, by the property owners for internal access, when the timber on the property was harvested. Babs' property conveyor should have advised her in 2005 when she purchased the property that she would need to make arrangements for access either through private property or via the reserved road that leads to her property.

Legal liability is a major issue with people using private property for access purposes; it is therefore advisable to have an agreement drawn up between the property owners and the users.

Babs was provided with this opportunity, as were the other 3 property owners Babs refers to.

This was via a suitable access that had been put in by the property owner at their expense; she chose not to take this option thereby restricting her access to her own property. Babs has also chosen not to use the option of the reserved road due to the expense of making it usable.

Of the other 3 property owners mentioned 2 have made arrangements for access and the other one has access through their own property, which Babs is currently using to access her property.

Just a reminder that entering a person's property without a valid reason can be classed as trespassing and be subject to legal action.

If anyone requires more information on this matter please feel free to contact myself or the property owner, I will not be making further comment on this matter via this medium due to future legal action.

I read with interest the Police Report in the last issue of the V V. Under the heading "Public Order Offences" the writer mentioned cases of anti-social behavior on the town. I was surprised there had been no statement of the vandalism done to our car outside the hotel on New Year's Eve.

In the 20 minutes where my wife took the time to have one New Year drink with friends inside the hotel, someone decided to jump on top of the car, use it as a trampoline, break off the aerial and urinate down the back window. I reported the damage to the local police when it was noticed on New Year's day and they commenced an investigation.

The history theme was the loading facilities and wharf built at Piccaninny Point around 1918 to ship coal from the Dalmayne Coalmine, which was situated some five kilometres inland from the point. Photos of the wharf and the aerial rope-way, which carried the coal from the mine to the wharf, were shown and Jim Haas told the story that saw only one ship load of coal leave the wharf before it was completely destroyed by a ferocious Southerly storm.

The twenty or so people who came on the walk all had a wonderful, informative and healthy day, which concluded with a feed of nice ripe blackberries picked straight from the bush. All those present said they can't wait for the next field trip, where we plan to walk to Kringle's caves on the 18<sup>th</sup> April, meeting at the Purple Possum at 10.00 am.





## The Tasmanian Lymphoedema Centre reaches 10 year milestone.

The Tasmanian Lymphoedema Centre Inc. was officially opened on the 28th February 2000, by Senator Jocelyn Newman, erstwhile Federal Minister for Family and Community Affairs –what an amazing period of time!

Following treatment for cancer in 1996, I developed secondary lymphoedema of the legs and became desperate to get some help for this debilitating condition, was given some information written by Pat Mather of Devonport and became the 4th Tasmanian to access assessment and treatment by Prof. Neil Piller and his team from Flinders University Health Centre. This was so successful, that I invited the team to Tasmania. To cut a long story short, they came, and we held a great workshop at St Marys Community Health Centre on the 24th April 1999.

The Lymphoedema workshop aimed at raising awareness of the condition and the effect it has on the sufferers. Also making treatment and management more effective.

In excess of 100 people from all parts of Tasmania turned up for the 2 day event, which was launched by Senator Jocelyn Newman, who spoke about her own need for treatment from the Adelaide team.

The workshops were such a success that immediate plans were laid to raise funds for a laser and to develop the St Marys Community Health Centre as a treatment centre with regular visits by Specialists like Professor Piller, to train local therapists and to provide a stress free environment and amenities for local accommodation.

Thus, 2 or 3 weeks later, the St Marys Breast Cancer Support Group, under the late Sandra Oliver and Dot White, organised a super soup and sandwich lunch in Scamander, which raised \$2300. This was hotly followed by a cheque for \$4000 from the St Helens Lions Club through the late Lyn Fysh and friends Barry Thorpe and Betty and Rex Sibley.

Much to my amazement cheques large and small came through my letterbox from groups and individuals— St Marys Lions Club, St Marys RSL, St Marys Football Club, Hospital Auxiliary, local Hydro boys.

Glenn Mc Donald ran a Hey, Hey it's Saturday, Bicheno ladies and Fingal ladies groups held fund raising lunches. I received letters and cards with cheques and support from across Tasmania and especially the Break O'Day community.

Then \$10,000 came from Lyn Fysh for the laser in St Marys and I had the pleasure of ordering the laser—another long story.

### **St Marys Police report**

Since my last report Police within the St Helens Division have again been kept busy with attendance at road crashes, crime scenes and reports of damage to property. These types of incidents are for police the bread and butter jobs, together with the old police saying of "dogs, drunks and domestics" that we deal with on a regular basis. There is a common factor in most of these incidents. Do you know what I'm hinting at? I have submitted a quiz in this report to test your knowledge on some road rules and other legal questions for your information and enjoyment.

### **CRIME REPORT**

St Marys police recently attended the scene of a burglary of a residence in Frederick Street, St Marys. Forensic samples were obtained from the scene and local police are conducting inquiries in an attempt to identify the offenders. It appears the offender(s) entered this residence during daylight hours whilst the owner was absent.

Property owners are asked to ensure their property is secured during those times you are going to be absent, even if only for a short period, as unfortunately there are opportunistic individuals whom will enter your home and steal your property given the chance to do so. Any form of security is better than none and these days some insurance companies will not pay out on a claim if a residence/property/vehicle is not secured.

### **TRAFFIC REPORT**

On Sunday 21/2/10 police and emergency services personnel attended the scene of a three vehicle crash on the Tasman Highway at Chain of Lagoons at the southern entrance to Lagoons Beach involving two motor cyclists and a 4wd towing a caravan. 

### Remember making an apron in Home Ec?

This story was sent to me via email and I thought I would share it with all the readers who, like me, may remember this era. I don't think the kids of today know what an apron is.

The principal use of Grandma's apron was to protect the dress underneath, because she only had a few, it was easier to wash aprons than dresses and they used less material, but along with that, it served as a potholder for removing hot pans from the oven.

It was wonderful for drying children's tears, and on occasion was even used for cleaning out dirty ears.

From the chicken coop, the apron was used for carrying eggs, fussy chicks, and sometimes half-hatched eggs to be finished in the warming oven.

When company came, those aprons were ideal hiding places for shy kids.

And when the weather was cold grandma wrapped it around her arms.

Those big old aprons wiped many a perspiring brow, bent over the hot wood stove. Chips and kindling wood were brought into the kitchen in that apron.

From the garden, it carried all sorts of vegetables. After the peas had been shelled, it carried out the hulls.

In the autumn, the apron was used to bring in apples that had fallen from the trees. When unexpected company drove up the road, it was surprising how much furniture that old apron could dust in a matter of seconds.

When dinner was ready, Grandma walked out onto the porch, waved her apron, and the menfolk knew it was time to come in from the paddocks to dinner.

It will be a long time before someone invents something that will replace that 'old-time apron' that served so many purposes.

REMEMBER:

Grandma used to set her hot baked apple pies on the window sill to cool. Her granddaughters set theirs on the window sill to thaw.

They would go crazy now trying to figure out how many germs were on that apron. I never caught anything from an apron. But love.




