## A LITTLE BIT OF HERITAGE: Jim Haas "The Timber Industry"

With the huge cut backs and loss of jobs in the timber industry in recent years, it's interesting to look back at the industry and see how important it's been to the economy of our State. Here in the Fingal Valley for example, the industry has been just as an important part of the economy as the coal industry. Indeed, back in the 1960s and 70s when the coal industry almost folded, it was the timber industry that supplied the bulk of the employment to our retrenched miners and kept them in the Valley.

Back in those days not only was Forestry a major employer in establishing pine plantations and managing the bush, but between Avoca, Fingal, Mathinna and St Marys there were up to ten small sawmills operating, most of which employed half a dozen or so men.

The timber industry is also one of our oldest industries; it can be traced back to when our early settlers arrived in the Valley back in the 1820s. They had to cut the timber and square it up with a broad axe to make it suitable for building. Later pit mills were established. This was where a log would be rolled over a pit and one man would stand under the log, while the other stood on top. The process was to continually cut through the log with a cross-cut saw until the timber was brought down to the size needed. One can only imagine what extremely hard and tiresome work this would have been, especially for the man under the log.

Mechanical sawmilling was introduced into the Valley by a young German immigrant by the name of Julius (Yuli) Aulich. Back in 1870 Yuli migrated from Prussia and along with his parents had sailed to Tasmania on board the ship "*Figaro*". After landing in Hobart, the family moved up the East Coast as far as Swansea, where the father, Wilhelm, worked as a shepherd. After five years at Swansea the Aulich family moved up to Gray and built a house beside the current Pancake Parlour. Although the house has changed a bit over the years, it still stands today.

By this time Yuli was an innovative young man and no doubt with plenty of energy. In 1884 he purchases a stationary steam engine along with a circular saw and set up a mechanical saw mill at Mill Ridge on the foothills of St Patricks Head.

Whilst this was the start of mechanical saw milling it did not eliminate the hard work, the trees still had to be felled with axes and cross-cut saws and hauled to the mill with horses or bullocks. But Yuli and his men developed a love for the industry and after a while would get what was termed as "sawdust on the brain" and wouldn't want to work at anything else. The reality of this is evident when you talk to blokes like Barry Aulich who carried on the tradition of his Great Grandfather and continued to introduce new modern methods into the timber industry. Indeed, Barry was one of the first in the area to use a chain saw way back in 1955. It was a Swedish Mobilco Bebo and in Barry's words: "as heavy as lead". But he must have reckoned it was the way to go because he left his cross-cut saw in a stump behind Beaumaris where it was found years later by Forestry workers.

Barry, like most of his mates in the timber industry, has retired now or moved on to other fields, their skills and experience no longer needed. Regrowth has almost hidden any evidence of the saw-mills that once provided a livelihood for so many good, honest, hardworking men.

It must be sad for these old bushmen to see the industry they loved and fought so hard to preserve slowly dying the way it is today. No longer is there a need for their traditional skills to be handed down to the current generation.

The politics that has contributed to all this happening is beyond comprehension for many of us. But surely the livelihood of so many families in a place like Tasmania, with an abundance of sustainable timber, should be a top priority for any political party.

Letter to the Editor

Still the Mayor has refused to answer the very important question that I have put to him on several occasions, even though I have been supported by a number of other letter writers asking the same question, but to no avail.

There is also a huge groundswell of concerned people in this municipality wanting answers, as this is vitally important to every land owner.

The question being, will the Break O'Day Council recognise, uphold and adhere to "**Fee Simple**" as described so unmistakably in every dictionary as "Total Ownership of Freehold Land" with all that this implies?

I recently gave three dictionary definitions of Fee Simple which were: "**A right in law to the use of land in the unconstrained sense**", "**Total ownership**" and "**Absolute possession**".

These three definitions all agree unanimously that the land "**Totally**" belongs to the owner who's name appears on the "Title Deed".

There is an "**Implied Right of Entry**" in law to anybody coming on lawful business, to open the gate and come up to the door and state their business (provided that there is not a sign telling them to "**Keep Out**"). But if there is nobody home, or if told to leave, then they must go directly off the premises. This was put to the test in 1991 in the case of Plenty vs. Dillon, where a policeman was told to leave by the land owner and refused to do so, and the law proved the policeman guilty of trespass and he was fined heavily.

There is also an "**Implied Right of entry**" in cases of imminent danger such as flood or fire, or to assist the police or other essential services carrying out their duty such as apprehending a felon or helping someone in danger or distress, but that is all!

The Mayor's blatant refusal to respond meaningfully to this question, gives me no other action than to call for his resignation on the grounds of **incompetence and corruption**. Incompetence for his refusal to answer, and corruption for refusing to uphold the Common Law rights of the ratepayers whose number one duty it is for him to defend.

I would like to direct the attention of readers to my two part article the second part of which is printed in this edition under **Deliberations**.

Here you will see what has happened in Queensland and is planned for the rest of Australia, unless we, the people put a stop to it.

And don't think that it can't happen here, for the plan is to deprive the Australian citizens of their Common Law rights in preparation for the full implementation of the "New World Order" (One World Government).

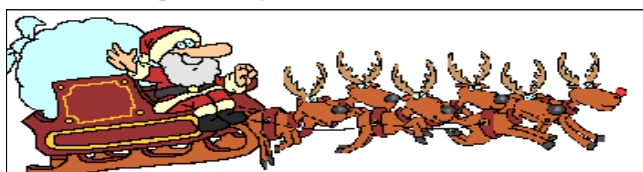
If we are to survive, the Mayor will have to be replaced with someone who will uphold our "**Common Law Rights**" and abide by the rules of "**Fee Simple**".

The National Australasian Convention was held at Sydney in 1891 to draft a bill to constitute a Commonwealth of Australia.

The President of the convention was Sir Henry Parkes. Delegates came from colonial states of Tas, NSW, Qld, SA, West Aust and N. Zealand.

The official record of the proceedings and debates of the National Australasian Convention held in Parliament House, Sydney, in the months of March and April 1891 was published by the Acting Govt Printer, George Stephen Chapman, 1891.

I quote from page cxxiii (123):

"By direction of Sir Henry Parkes, the following telegram which was received after the convention had been dissolved, was recorded:-

Telegram from Rockhampton to the Honorable Sir Henry Parkes, President of the Federal Convention, Sydney.

"That on behalf of the Central Queensland Territorial Separation League, we the undersigned respectively but strongly protest against the restrictive provision adopted to the creation of new states, which makes it imperative that the consent of the Parliament of the State concerned must first be obtained. We would point out that in no case has any Australian parliament consented to the separation of territory, and that the retention of such restriction would be an act of gross injustice, as it would block the creation of any New States.

John Ferguson, President. John Murray M.L.A., Vice President. George Silas Curtis, Chairman of Executive Committee. Sidney Williams, Vice-Chairman of Executive Committee. Central Queensland Territorial League."

The "Confederate Action Party" is a relic of this movement, operating on misinformation and conspiracy theories - an attempt to create a separate Qld State, without the constitution.

### CORNWALL FIELD TRIP

Despite a rather suspect day weather wise, a dozen brave souls turned out to learn the history of Cornwall and walk to the old Coal Mine Bank-top. From there Jim Haas led the group onto the old Eastern Tram-way and followed it to the remains of the old Eastern Mine, some two kilometres towards Jubilee.

The old Eastern Mine actually went all the way through the mountain and came out overlooking Dublin Town. It was also one of the last mines worked in the old section at Cornwall before it closed in 1964.

The coal was transported from the mine to the bank-top with a diesel loco, parts of which can still be found in the vegetation around the old Cornwall mine site

## Christmas Legacy. Beverley Rubenach

In my family, storytelling has always been an intrinsic part of Christmas preparations;

"I remember Christmas when I was young," my mother would begin. Her eyes sparkled, her face glowed at the flood of joyful memories. Her voice captured all the vitality and enthusiasm of youth. Transported back in time, she was no longer Linda Mitchell, wife and mother but the child Linda Newman. On the family farm about 2kms from St Marys she was enjoying a carefree, simple life with mother, Mary, father, Jack, sisters Elsie, Clarice, Doris, Gwen and Phylis and brothers Frank and Tom.

School at St Marys was dismissed for the day. Gwen's gorgeous black curls bounced to the rhythm of her dancing, as she left the school ground. "Teacher has chosen ME to recite the best, the longest and most difficult poem at end of year recital," she called loudly and proudly, looking back at the rest of us sauntering homeward. It had been announced to the whole school so Elsie was justifiably annoyed when she chided, "Oh hush up, Gwen."

"Why Maude, you are envious," Gwen responded. Calling Elsie by her name, Maude, spelt trouble, but the elated Gwen wanted a challenge. She knew she was the brightest, best and most popular girl in school, and heaven help anyone who denied it.

I loved Gwen far above my other sisters and brothers but for now I was deeply hurt and very angry. Teacher could have chosen me. I could recite 'The song of Hiawatha' as well as Gwen. "You only got to do it because you are teacher's pet."

Some of Gwen's joy disappeared. Seeing victory I continued. "You are only teacher's pet because you are pretty, not because of brains." Gwen's angelic look vanished. I knew what that meant! I raced past her and bolted for home.

It was a sweltering summer's day so when I felt there was a sufficiently safe distance between me and Gwen, I stopped running. That allowed me to make the greatest discovery of the year. There it stood - inconspicuously soaking up the afternoon sun - a solitary small white flower protruding from a sturdy stem. "A snake lily! A snake lily!" I shouted. Sisters, brothers, neighbour's children - all who walked that same bush track, crowded around me in silent awe.

Faces were alight with delight and anticipation. "Now we know for sure Christmas will soon be here," Gwen whispered. All thoughts of school recital were forgotten - Now it was only Christmas.

"Well done Linda," everyone congratulated, thumping my back. Gwen hugged me. To us country children the wild white iris was the herald of Christmas. Discovering the first bloom of the season was the pinnacle of success.

Frequently being in the bush wood-cutting, the boys were always the ones to find this treasure. Some years the Newman boys took the honour, some years the Tapp or Gillies boys, but NEVER had a girl been the victor.

The rewards started coming. Anything in everyone's pockets was mine - a half sucked aniseed ball, a sliver of muskstick, a grubby peppermint, a licorice stick full of toothmarks, a dirty handkerchief. Owners gladly gave their all.

The discovery meant Christmas preparation beginning in earnest, especially our family traditions. That meant each child finding and decorating their own peppermint tree on Christmas Eve. Some of the sophisticated St Marys children called us country bumpkins. Their families, they told us, had "a proper Christmas tree." How silly - having a pine tree in the living room and just one tree for a whole family. We each had our very own native tree tied to our very own verandah post. Nothing could beat that!

Christmas Eve saw eight children eat a hasty breakfast and rush through chores. Each ran to their own secret place to cut down and drag home their perfect tree. Then came the critical part - decorating. Each year Mother judged "best tree". Wildflowers tied in bunches were the decorations. Collecting wild violets, everlasting daisies and trigger plants meant crawling on hands and knees in bushland infested with jackjumpers (and the occasional snake). Gathering shivery grass meant invading pastureland patrolled by honey bees.

Bites and stings were largely ignored for the trees must be decorated. Once every tree was complete there was a treat for us all - Christmas cake and ginger beer.

Tom and Frank decorated their trees haphazardly! Clarice took forever arranging and rearranging. Our impatience with this perfectionist sister made it hard to retain "the Christmas Spirit", so we went and played rounders. That afternoon we gave the rounders ball a name - Clarice. It is amazing how pent up frustration releases muscle power. A lot of home runs were scored.

Eventually Clarice called "finished". After treats Mother declared, "judging time". Clarice's tree was, as always, perfect. How disappointed everyone would be when she was declared winner. It wasn't so bad for me and Gwen. We had past triumphs to remember - my snake lily discovery - Gwen's successful school recital.

Mother stopped by each tree and smiled contentedly at each proud owner. Each tree was found to be beautiful. Mother could see what we could not. Amidst Frank's shambled flower arrangement, a golden beetle nestled. On Tom's tree, Mother delighted in a small caterpillar humping along the branches. Each child was praised for their creativity and individuality. Each child was hugged and told how much they were loved. Then the announcement. "Children, I declare you all equal winners." From her apron pocket she produced eight small bags of her special butterscotch. Everyone hugged her. There was no trace of disappointment, only sighs of relief and happy faces.

The result was the same as last year and hopefully it would always be so and it was the way it should be. Oh wise and wonderful Mother. She taught us to experience and appreciate the celebrations of Christmas with simplicity, love, joy and family peace and unity - just as it should be. What a legacy she gave me.

### Epilogue

For over 40 years my mother told me her "I remember Christmas" stories. Sadly, Christmas Eve 1998 saw her hospitalized semiconscious, with terminal cancer. We visited her that evening and sang her favourite Christmas Carol. "Hark the herald angles sing - glory to the newborn king. Peace on Earth and mercy mild - God and sinners reconciled.."

She opened her eyes, smiled and squeezed our hands. Unable to talk coherently her eyes were pleading for an answer to the question she could not ask. "Yes", I reassured her, "There are nine peppermint trees tied to our verandah posts - one for each of us and one especially for you." She smiled in delight at

Peter and her 6 grandchildren. She squeezed my hand and her face flooded with total peace. She sank back to virtual unconsciousness but all was well. Her Christmas legacy was my Christmas legacy. Christmas would continue to be celebrated with simplicity, love, joy and family peace and unity - just as it should be.

Thank you wise and wonderful Mother!

# Child Restraints

## Changes have been made to the road rules about child restraints and there will be further changes.

**From 30 November 2010**, children: aged four years to less than the age of seven must be restrained in either an approved forward facing child restraint with an inbuilt harness or an approved booster seat restrained by a correctly adjusted and fastened seatbelt.

Children aged less than four years of age are already required to wear an approved child restraint that is properly fastened and adjusted when travelling in a car for improved safety. The type of restraint will depend on the age of the child as follows:

**under the age of six months:** to be restrained in an approved rearward facing child restraint (e.g. infant capsule)

**from six months to less than the age of four:** to be restrained in either an approved rearward facing child restraint or an approved forward facing child restraint with inbuilt harness (e.g. child safety seat)

There are also new laws about where children can sit in vehicles.

If a car has two or more rows of seats, then children under four years must not travel in the front seat.

If all seats, other than the front seats, are being used by children under seven years, children aged between four and six years (inclusive) may travel in the front seat, provided they use an approved child restraint or booster seat.

### Penalty

The penalty for failing to ensure a child aged under 16 years wears a child restraint or seat belt is 3 demerit points and a \$350 fine.

### DIER also recommends

That you have restraints fitted by an experienced child restraint fitter.

### What you have to do

To comply with the new child restraint rules you have to: know which is the correct child restraint(s) to use; and ensure that each child passenger is wearing a properly fitted and fastened approved child restraint suitable for their age every time you drive a car.

Further advice on appropriate child restraints and fitting services is available from organisations such as Kidsafe and RACT or check your telephone or business directory for local providers.

### Road safety reasons

On average, nearly 38 children under the age of seven are injured or killed as passengers in vehicles on Tasmanian roads each year.

Parents are generally moving their children into adult seatbelts from about the age of five and half years - research suggests this is simply too early.

Children up to seven years are at least four times more likely to sustain a head injury in a crash when sitting in an adult seatbelt only.

Other research shows seating children aged four to seven years old in an appropriate booster seat reduces their risk of injury in a crash by almost 60 per cent, compared to if they were sitting in an adult seatbelt without a booster seat.

### Exemptions

Taxi drivers are exempt from the above rules if there is no child restraint available in the taxi. However, taxi drivers will be responsible for ensuring a child aged 1 year to less than 16 years wears an available seat belt to the best extent possible given the height and weight of the child, if there is no available child restraint.

Parents are encouraged to use their own restraints in taxis where possible...

# Seatbelts

**From 30 November 2009 there will be some changes to the road rules about seatbelts**

## **Drivers to make sure seatbelts and child restraints are used**

It is the responsibility of the driver to ensure that all passengers in the car are wearing a seatbelt or a child restraint. Drivers must now also ensure that adult passengers wear a seatbelt.

When all seatbelts or child restraints are used, no extra unrestrained passengers can travel in the vehicle.

## **Penalties**

Penalties for seat belt and child restraints offences now range from \$300 to \$350 fine and 3 demerit points for drivers and \$300 fine for passengers.

## **Exemptions**

This rule does not apply to the driver of a bus. The rule also does not apply to a taxi driver with passengers 16 years old or older.

However, an adult passenger commits an offence themselves if they travel in a taxi without a seatbelt, as they would in a private vehicle.

Also there are exemptions for some types of vehicles that are not required to be fitted with seatbelts (eg vintage cars).

Medical reasons for exemptions - people in Tasmania can only be exempt from wearing a seat belt for medical reasons if they are carrying an exemption issued by the Registrar of Motor Vehicles.

## **Seatbelts**

### **What you have to do**

As the driver, you have to ensure that anyone travelling in the vehicle is in their own child restraint (refer to the new rules for child restraints) or seatbelt.

Drivers have to also ensure that passengers of any age do not travel in or on parts of a vehicle that are not enclosed.

### **What should a driver do if a passenger refuses to wear a seatbelt?**

A driver must ensure each passenger is wearing a seatbelt or is in an approved child restraint before starting the vehicle. If the driver notices the passenger has undone their seatbelt, the driver should request that it be done up. If the passenger refuses to re-fasten the seatbelt, the driver should stop the car when safe to do so.

It is important to remember that, in a crash, an unrestrained passenger has a much greater risk of injury or death or may cause injury or death to the driver, or other passengers within the car.

### **Road safety reason**

Wearing a seatbelt is one of the simplest and most effective ways of protecting drivers and passengers. Each year about 28 per cent of all car occupants killed in road crashes were not wearing a seatbelt.

Answer to a letter to the editor in Vol 43 No 13 2010. To clarify the requirements of interstate vehicles here is the information from the Transport website:

Visitors to Tasmania who do not have a Tasmanian residential address are exempt from the requirement to transfer vehicle registration.

Residents of Tasmania who bring a mainland registered vehicle into Tasmania have 3 months to transfer the registration. They must make arrangements to have the vehicle inspected and registered in Tasmania to be able to continue to use the vehicle on Tasmanian roads after the expiration of the 3 months.

If anybody has a vehicle which is currently registered interstate and they have any queries in relation to the requirements to transfer it into Tasmanian registration please contact their local police station.

## Councillor's Corner

This article is being written in response to questions that have been directed at me by concerned residents about the telecommunication tower on the St Marys Recreational Ground, and the following are extracts I have gleaned from the tabled and passed Council Minutes from June 2008 to November 2010. If any resident seeks further information or clarification then they should contact the Mayor, as he is the spokesperson for the Council.

Please bear in mind that the Crown owned this parcel of land at this time and Council was the occupier. Daly International required Council's consent to a Development Application before they could approach the Crown. Also this tower meets all the Australian Standards for EM Radiation.

**Community Benefits from Record Infrastructure Funding**

Local residents are set to benefit as the Minister for Regional Australia, Simon Crean, announced approval of \$100 million funding for community infrastructure across Australia.

“More than \$1 million has been invested in 25 community infrastructure projects in the Lyons electorate, through the Regional and Local Community Infrastructure Program.

“This funding has given local councils the opportunity to make much needed upgrades to community areas and facilities.

“The Break O’Day Council has nominated the Beaumaris Multi User Pathway, a 1km stretch of sealed pathway to allow safe walking and cycling along a busy stretch of highway,” Dick Adams, Federal Member for Lyons said.

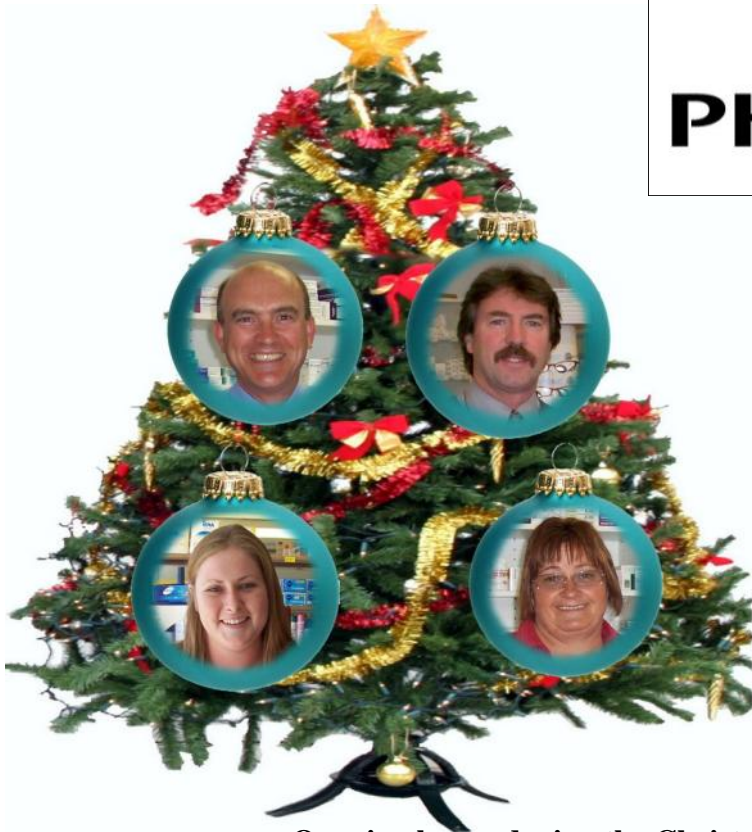

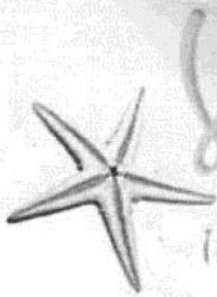

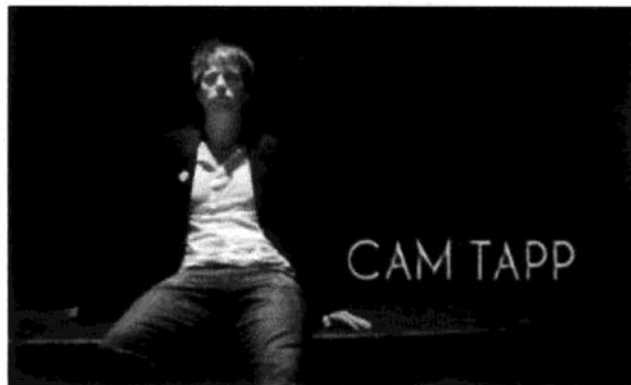

### Tasmania Leading the Nation in e-learning

Tasmania is again leading the nation, with the highest uptake of e-learning in Australia.

The Minister for Education and Skills, Lin Thorp, recently opened the TasEday 2010 Sustaining e-learning event in Hobart.

56 per cent of Tasmanian learners are using e-learning, compared to the national average of 43 per cent.

"Tasmania will be the most connected place on the planet by 2014, creating even more e-learning opportunities," Ms Thorp said.

"The National Broadband Network will revolutionise the way we teach our young, look after our patients, run our businesses, and connect with the rest of the world.

"e-learning gives learners the choice of what, when and where they study. It's flexible learning at its best.

"That's a great way to encourage participation – whether in study, work, or play.

"As a Government, we're determined to give every Tasmanian the opportunity to participate in the things that fulfil them, and help them reach their potential."

Ms Thorp said e-learning can be especially useful in the workplace, where it's cost-effective, and particularly suited for things like induction and skills training.

"Tasmania receives Australian Government funding as part of the Australian Flexible Learning Framework, the national training system's e-learning strategy," she said.

"Since 2008, more than \$850,000 has been distributed to registered Tasmanian training groups, as well as their enterprise and community partners, as part of the framework's Tasmanian e-Learning innovations program.

"10 Tasmanian projects are being run in 2010 through the Australian Flexible Learning Framework.

"The recent event helps bring everyone up-to-date on the latest offerings in e-learning – which can only continue to grow in coming years.

"It's a fantastic way to highlight how Tasmanians are embracing e-learning."

### NATIONAL ROAD SAFETY STRATEGY TO SAVE TASMANIAN LIVES

Lyons residents are encouraged to help save lives on our roads by providing their ideas on road safety with the release of the draft National Road Safety Strategy 2011-2020.

Parliamentary Secretary for Infrastructure and Transport, Catherine King, joined Federal Member for Lyons, Dick Adams, to call on Lyons residents to have their say on the draft Strategy released by the Australian Transport Council (ATC).

Ms King said the draft was a national collaboration between Australian and state and territory road and traffic authorities and now it was time for the community and experts alike to have their say before finalising the strategy to commence next year.

Dick Adams, Federal Member for Lyons, said around 1,500 people lose their lives each year and a further 30,000 are hospitalised as the result of road crashes.

"This strategy is particularly important to the people of Lyons as the electorate spans over half the State, and covers many of Tasmania's major roads, as well as the more treacherous smaller roads.

"We've recently seen some very near misses in the Derwent Valley and some other very serious accidents across the State.

"The draft strategy is a key element in delivering safer roads and recognises that death and serious injury should not be accepted as an inevitable cost of road travel," Dick Adams said.

Mr Adams said that it was important that the local community had a say, and urged residents to look at the strategy and provide a submission.

"The road trauma statistics are far too high, we need to stop the loss of life and serious injury on our roads," Dick Adams said.

Ms King and Dick Adams said the Australian and State and Territory governments have worked together on this key strategy to save lives across Australia.

"Everyone can provide input on the draft which is aimed at Safe Roads, Safe Speeds, Safe Vehicles, and Safe People," they said.

The draft strategy targets a 30 per cent reduction in fatalities and serious injuries in the next ten years.

The consultation period closes on 11 February 2011.

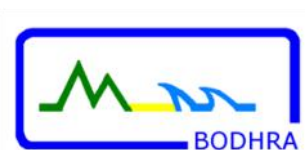

# DELIBERATIONS

Following on from the previous edition in which I pointed out how Queensland has lost its Common Law rights and become a Corporation...

So now, all Crown land, assets and infrastructure in Queensland including schools, hospitals, roads etc are subject to and responsible to the Ministers of the State of Queensland as cited at Chapter III of the Queensland Constitution 2001. All Sovereign People are now persons under the Corporation and therefore can be classed as chattel.

Their land, bank accounts and all items of ownership are now assets under the Corporation. The Supreme Court, the District Courts and the Magistrates Courts are now inside the Parliament of the State of Queensland, and as such must obey the Queensland Constitution 2001.

The Australian Constitution, Common Law and Equity, the High Court and the Federal Government no longer have superior governance over the State of Queensland.

The State of Queensland and the Sovereign People of Queensland now have only Civil and Statute Law in that State. As private ownership can not exist under Civil and Statute Law, all private equity and inheritance in the State is now the property of "The State".

Under the civil law system, which is now subject to the Uniform Civil Procedures Rules of the supreme Court Act 1991 (Qld), every person is guilty until they are proved innocent.

The Common Law has been repealed from the supreme Court act 1995 (Qld), Reprint No.2, reprinted as in force 2 March State of Qld.2001. This states that the Governor in Council may make rules of Court under this act for the Supreme Court, District Court, Magistrates Court, Registries and other matters mentioned in Schedule 1.

Therefore, the Governor in Council now makes all of the Rules of the Court for these matters. Consequently, the Premier of Queensland must always be the leader of the Executive Body and is now the Executive Leader of the Parliament of Queensland. Meaning that the Premier is delegated the power through his role as Chief Executive. This power controls the Executive Government of Queensland. The Governor acts on the advice of the Executive Government.

This means that the **Premier is now "the Crown" in Queensland!!!**

Although these "rules" have been implemented, they are not being fully used yet, as doing so would alarm the rest of the population and would undoubtedly cause a huge public backlash which would probably disrupt further implantation. They are being reserved for future use as population control.

The media have done a magnificent job of keeping this vital information from the public gaze, usurping their responsibility in doing so to their everlasting condemnation.

We must now ask ourselves what this means to the rest of Australia? I understand that N S W is next in line for constitutional destruction to be followed by the other States. So how can we fight this massive assault on our freedom and liberty? I believe that the most effective opportunity available to us is to ensure that our, as yet indisputable and fully legal ownership of freehold land is not allowed to be whittled down or changed in any way whatsoever.

It has historically been a most fundamental right of a man to build a home of his own for himself and his family without restriction or interference. This has been under threat for some time, but has now escalated considerably with the introduction of the 1993 Local Government Act which is totally unconstitutional and therefore illegal! And remember that this was implemented five years after we had a referendum in which the people voted overwhelmingly against it happening, with the greatest **NO** vote being here in Tasmania at 72.50%.

We have here a form of theft, whereby corrupt people in power take any means at their disposal to rob the population of their inheritance and they must be stopped if we are to live a free, happy and fruitful life.

If you rob the people of their rights, if you rob them of their identity, if you rob them of their democracy, all that is left is fanaticism and violence!!!

**I demand full reimplementation of our Common law Rights and Full, Fee Simple Ownership Rights!!! Who is with me???**

Well what a Night!!! On 20<sup>th</sup> November 2010 we held a very successful Autism awareness and fundraising night.

1 in approximately 58 children are now being diagnosed on the Autism Spectrum Disorder.

Autism may affect delays in 3 main areas:

- Social interaction
- Speech
- Communication

Children diagnosed on the Autism Spectrum Syndrome may experience developmental delay in these three areas. "Delay being the key word" There is hope, dreams do come true and every small hurdle they overcome is a huge one bringing delight and confidence that they can achieve.

Children on the spectrum are often misjudged and parents are criticised for their behaviour as they have no physical difference in appearance. They often can have sensory issues as noted below.

The five senses:

- Touch – Very tactile. Feeling surfaces in a different way. Stimming.
- Taste – unusual reactions to flavours or textures
- Smell – Certain smells can cause an overreaction melt downs can occur
- Sound – Tones, Pitch can affect ear drums making it physically painful to comprehend
- Sight – may have peripheral vision (side vision) inability to focus or maintain eye contact

No child on the spectrum is the same. Every one of them have their own special interests which can change regularly and their own impairments to deal with. They are unique in their own way.

We wish to thank everyone that helped us with our fundraiser but there is just a few which I wish to mention:

Support came from all over the state. From St Helens to Pyengana, Launceston to Hobart, Bicheno to Scamander.

We are ever so grateful to the local community for their generous donations and support to help us raise the awareness and also enough funds to continue our mission.

Just over \$6000 was raised on the night. We also receive a \$300 grant from Gunns Ltd to help us organize a sailability day for children on the spectrum early next year and a \$200 donation from Scamander Beach Social Club.

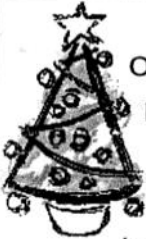
During the months on December 2010 and January 2011 the St Marys Community Health Centre is having an Amnesty on ALL Equipment loans.
